## Administration (9:00 – 9:05)

Stefan Starkov, PJM, reviewed the Antitrust, Code of Conduct, Public Meetings/Media Participation and WebEx Participant Identification Requirements.

**The committee approved the draft minutes from the August 6, 2025 Market Implementation Committee meeting by acclamation with 0 objections and 0 abstentions.**

## Endorsements (9:05 – 10:20)

### 1. Resource Scheduling Prior to the Day-Ahead Energy Market (9:05 – 9:20)

Phil D'Antonio, PJM, presented a second read of a solution proposal for Phase 1 of Offer Capping for Resources Scheduled Prior to the Day-Ahead Energy Market within the matrix.

**The committee endorsed the solution proposal at this meeting with 183 (98.4%) in favor, 3 (1.6%) opposed, and 15 abstentions. A second vote showed stakeholders preferred the solution proposal over the status quo with 184 (98.4%) in favor, 3 (1.6%) opposed, and 14 abstentions.**

### 2. Quadrennial Review (9:20 – 10:20)

- a. Skyler Marzewski, PJM, and Christian McDowell, PA Public Utility Commission, presented two solution proposals from PJM and VC Barrow PA PUC developed from the Quadrennial Review sessions.
- b. Joe Bowring, Monitoring Analytics, presented a second read of the IMM solution proposal developed from the Quadrennial Review sessions.
- c. Tom Hoatson, LS Power, presented a second read of two LS Power solution proposals developed from the Quadrennial Review sessions.
- d. Christian McDowell, PA Public Utility Commission, presented a second read of the VC Barrow PA PUC solution proposal developed from the Quadrennial Review sessions.

**Following discussion, the committee voted on the proposals with results as follows:**

**The committee endorsed the PJM & VC Barrow Package (using CT as reference resource) at this meeting with 113 (54.9%) in favor, 93 (45.1%) opposed, and 24 abstentions. A second vote showed stakeholders did not prefer the solution proposal over the status quo with 91 (44.0%) in favor, 116 (56.0%) opposed, and 24 abstentions.**

**The committee did not endorse the PJM & VC Barrow Package (using CC as the reference resource) at this meeting with 58 (26.6%) in favor, 160 (73.4%) opposed, and 13 abstentions. A**

second vote showed stakeholders did not prefer the solution proposal over the status quo with 59 (27.1%) in favor, 159 (72.9%) opposed, and 13 abstentions.

The committee did not endorse the IMM package at this meeting with 49 (22.4%) in favor, 170 (77.6%) opposed, and 12 abstentions. A second vote showed stakeholders did not prefer the solution proposal over the status quo with 49 (22.4%) in favor, 170 (77.6%) opposed, and 12 abstentions.

The committee endorsed the LS Power Package (using existing VRR curve) at this meeting with 114 (55.6%) in favor, 91 (44.4%) opposed, and 26 abstentions. A second vote showed stakeholders preferred the solution proposal over the status quo with 114 (55.6%) in favor, 91 (44.4%) opposed, and 26 abstentions.

The committee did not endorse the LS Power Package (using 2018 VRR curve) at this meeting with 90 (43.9%) in favor, 115 (56.1%) opposed, and 26 abstentions. A second vote showed stakeholders did not prefer the solution proposal over the status quo with 90 (43.9%) in favor, 115 (56.1%) opposed, and 25 abstentions.

The committee did not endorse the VC Barrow PA PUC Package at this meeting with 46 (21.3%) in favor, 170 (78.7%) opposed, and 15 abstentions. A second vote showed stakeholders did not prefer the solution proposal over the status quo with 46 (21.3%) in favor, 170 (78.7%) opposed, and 14 abstentions.

These package proposals will move on to the Markets & Reliability Committee for an advisory vote.

#### **Antitrust:**

It is PJM's policy to comply with applicable antitrust laws. Participants must not disclose or exchange non-public, competitively sensitive information about their individual business strategies. Prohibited topics include, but are not limited to:



- Non-public individual pricing strategies, bidding strategies, or offer practices
- Non-public forecasts of prices, costs, output, or market behavior
- Non-public information about the availability, output or production costs of specific resources or services
- Confidential terms or conditions of sale, service, or trading strategies
- Planned or potential allocation of specific customers, suppliers, or markets among competitors
- Agreements or understandings between or among competitors to limit supply, coordinate bidding, fix prices, divide markets, or refuse to deal with particular entities
- Any other communication that could unreasonably restrain competition or coordinate competitive behavior among market participants

Discussion of PJM-administered market rules, tariff provisions, system operations, and public market outcomes is appropriate, provided individual confidential business information is not shared. These permitted discussions may include advocacy positions, including those reflecting state regulatory responsibilities or consistent with the obligations and interests of state-regulated entities. These discussions occur in a context where resulting rule changes may be submitted to FERC for approval, or may reflect regulatory mandates established by state authorities.

If prohibited topics are raised, the Chair will redirect the conversation. If the discussion continues, participants may be asked to leave the meeting or the meeting may be adjourned.
