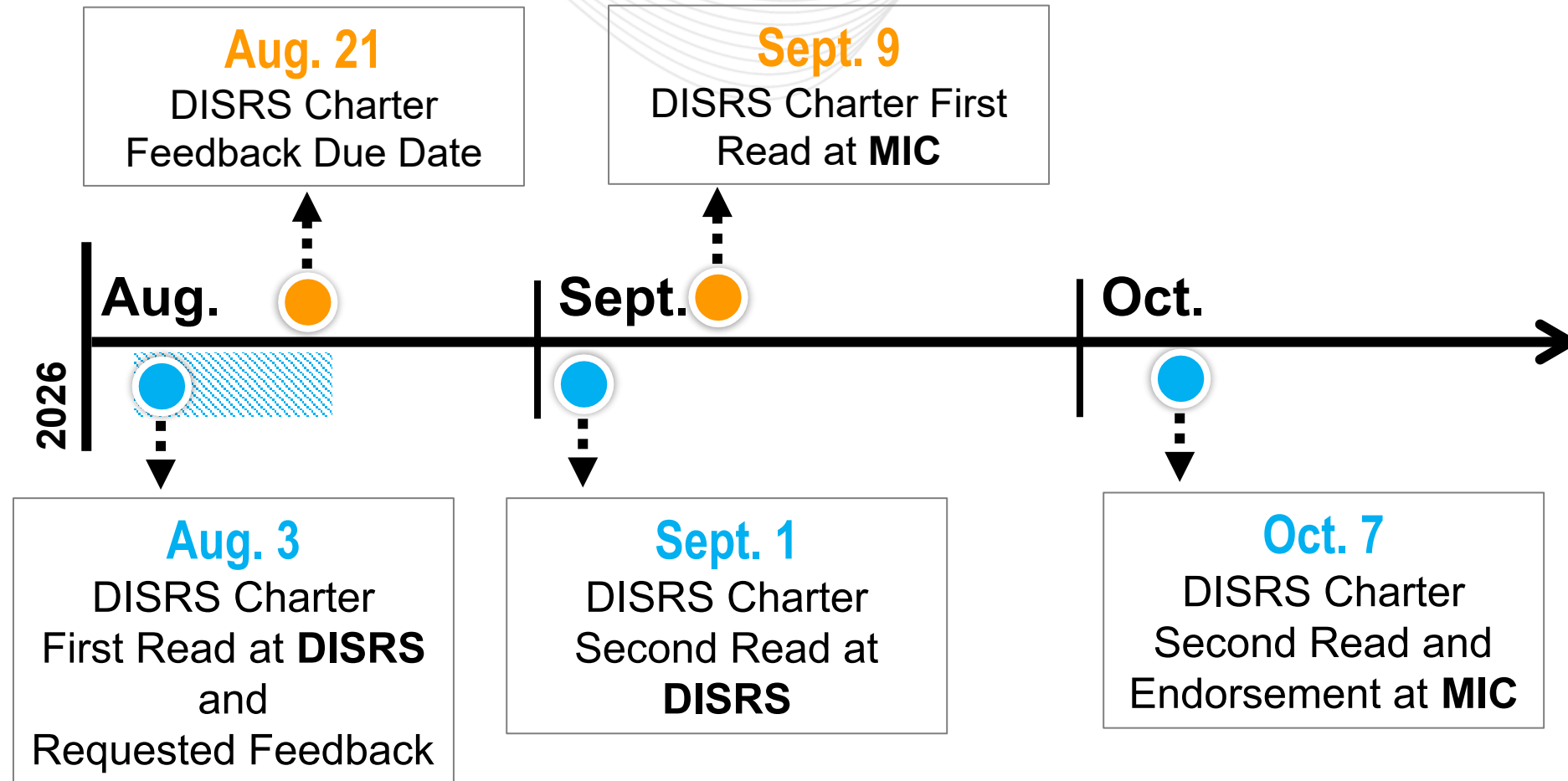

DISRS Charter Review and Updates

- Last updated in 2022
- Initial creation based on consolidation of Demand Response Subcommittee (DRS) and DER & Inverter-Based Resources Subcommittee (DIRS)
- Changes to align with general charter template updates
- Language alignment to overall purpose of DISRS



- Update/Addition of sections based on new charter template
 - Updated *Responsibilities* to **Responsibilities & Scope**
 - Added **Expected Deliverables**
- Moved final bullet under current Responsibilities to Expected Deliverables section
- Cleanup of language in Administration section to avoid redundancy in Manual 34

Responsibilities & Scope:

- Review ongoing participation of demand response, distributed resources and inverter-based resources in the wholesale markets.
 - For the purposes of this subcommittee, distributed resources include, but may not be limited to, Demand Response, Demand Resources, Economic Load Response Participants, Behind-the-Meter Generation and participants in Price Responsive Demand, Peak Shaving Adjustment, and the DER Aggregator Participation Model, ~~Component Distributed Energy Resources¹~~, ~~Behind-the-Meter Generation~~, and ~~Energy Efficiency Resources~~.
 - For the purposes of this subcommittee, inverter-based resources are any resource-type using power electronic equipment to convert direct current to alternating current (DC-to-AC) in order to synchronize to the electric system. This includes, but is not limited to, resource types such as wind, solar photovoltaics, energy storage technologies, and hybrid resources.

Expected Deliverables:

- Recommend necessary enhancements to PJM rules, systems, and procedures to ensure transparent, fair, safe and efficient wholesale market operation of distributed resources and inverter-based resources.
 - ~~Inverter based resource enhancements are likely to occur at many levels of the PJM stakeholder process, including standing committees. Not all inverter based resource issues need to be worked in this subcommittee.~~

- Cleanup of component language and inclusion of distributed resources terms
- Removal of footnote as details are now fully defined in the OATT
- Removal of language under new Expected Deliverables area to avoid redundancy

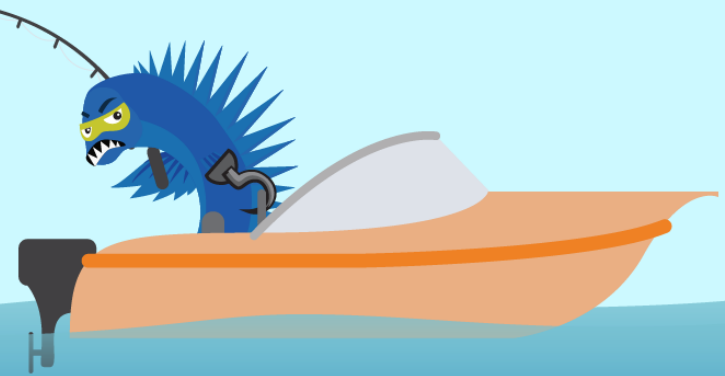
