Consent Agenda

Endorsements

X. Manual 14H: New Service Requests Cycle Process Revisions

Jason Shoemaker reviewed proposed revisions to Manual 14H: New Service Requests Cycle Process addressing the cycle process and site control modifications. Emma Nix Simon, EDF Renewables, discussed a pending complaint at FERC related to the site control provisions. John Miller, NedPower Mount Storm, LLC, moved and Josh Ghosh, Cypress Creek Renewables, LLC, secoded deferring voting on these proposed revisions for one month. The motion to defer voting on the proposed revisions for one month was **approved** by acclamation with no objections or abstentions.

Issue Tracking: Site Control Modification Clarification

1. Load Drop Estimate Guidelines

Andrew Gledhill reviewed a proposed problem statement, issue charge, and solution addressing the calculation and use of load drop estimate guidelines for load forecasting purposes.



Rebecca Stadlemeyer, Gabel Associates, proposed an amendment to add "(with communication to the appropriate PJM stakeholder group)" following "... energy load reductions" in the proposed revisions shown below:

Load drop estimates, as calculated in this manual or otherwise calculated by PJM to reflect the estimated hourly energy load reductions, are used to construct unrestricted loads used in the PJM Load Forecast Model, weather normalization of PJM seasonal peaks, and to calculate the unrestricted Peak Load Contributions used in formulating capacity obligations.

There were no objections to this proposed amendment, and therefore it was incorporated into the proposed manual revisions. Following discussion, the committee **approved** the proposed Issue Charge and **endorsed** the amended proposed Manual 19 revisions as part of the Quick Fix process outlined in Section 8.6.1 of Manual 34 by acclamation with no objections or abstentions.

2. Capacity Market Enhancements - CETL Issue Charge

Michele Greening reviewed proposed reassignment and timing updates to the Capacity Market Enhancements - CETL Issue Charge. Following discussion, the committee **approved** the Issue Charge reassignment and timing updates upon first read by acclamation with no objections or abstentions.
