- Section 1.10 Planning Systems, Added reference to Manual 20A Resource Adequacy Analysis.
- Section 3.2.4.1 Requirements for Electronic Alternate Data Communication Method
 - Updates to all rating and monitored equipment language for consistency with other PJM Manuals.

Endorsement Summary - Periodic Review

- Section 4.5.3 PJM Com Protocols, Definitions
 - Update "rating" to "Transmission Facility Rating" for consistency with other PJM Manuals.
 - Replaced "When the final Step is cancelled" to "When all Capacity Emergency Procedure Steps (1-10) are cancelled" for clarity and precision, for end of Emergency operating mode communications.
 - Replaced "Load shed" with "Load Shed Directive" for appropriate term use.

 - Update "facility rating" to "Transmission Facility Rating" for consistency with other PJM Manuals..
- Attachment A: Data Specification and Collection, Table B: EMS Services, changed definition of #8 for row B.6, which makes state of charge required for Open-Loop Hybrid Resources in addition to existing Energy Storage Resource Model Participant. These revisions conform to the FERC Order addressing the Hybrids Phase II solution.


