2. Modeling Users Forum (MUF) Charter

Jeff Schmitt reviewed a proposed Charter to convert the current Data Management Subcommittee (DMS) to a Modeling User Forum (MUF). Following discussion, the committee **approved** the proposed MUF Charter by acclamation with no objections or abstentions.

3. Deactivation Enhancements Senior Task Force (DESTF)

Chantal Hendrzak provided an update regarding the activities of the Deactivation Enhancements Senior Task Force (DESTF) and reviewed the proposed solution package endorsed by the DESTF and corresponding Tariff revisions. Following discussion, the committee **endorsed** the proposed Tariff revisions in a sector-weighted vote with 3.804 in favor. Same day endorsement will be sought at the January 23, 2025 Members Committee (MC) meeting.

Susan Bruce, PJM Industrial Customer Coalition, proposed an amendment to the posted proposed Issue Charge revisions to add "... ELCC accreditation *and other relevant planning parameters* between the time ..." in Key Work Activity 5. There were no objections to this amendment.

Susan Bruce moved and, Tom Hoatson, LS Power seconded the proposed Issue Charge update. Following discussion, the committee **approved** the proposed Issue Charge revisions by acclamation with no objections or abstentions upon first read.
