### Administration

Lisa Drauschak and David Anders welcomed stakeholders and provided the Antitrust, Code of Conduct, and Meeting Participation announcements.

Shanna Hartung announced that WinUp will be hosting Amy Wanninger, founder of Lead at Any Level, who will present "Networking Beyond Bias" on March 20, 2025 from 9:30 to noon. All stakeholders were invited to participate. The meeting will be held at the PJM Conference and Training Center

Donnie Bielak discussed the February 11, 2025 FERC order in Docket ER25-778-000 related to Surplus Interconnection Service, and the implementation of conforming manual revisions. He indicated that the proposed conforming manual revisions may be presented at the March Planning Committee and Markets & Reliability Committee (MRC) meetings, with endorsement at first read expected to be requested.

### **Consent Agenda**

Items A through C were **<u>approved/endorsed</u>** by acclamation with no objections and one abstention:

- A. Minutes of the January 23, 2025 meeting of the Markets and Reliability Committee (MRC).
- B. Proposed revisions to Manual 13: Emergency Operations addressing a new PJM Wild Fire Procedure to allow for coordination with Transmission Owners prior to or during a wild fire event.

### **Endorsements**

1. Manual 14H: New Service Requests Cycle Process Revisions

John Miller, NedPower Mount Storm, LLC, moved and Tom Hoatson, Rolling Hills Generating, LLC, seconded deferring voting on these proposed revisions for one month. The motion to defer voting on the proposed revisions for one month was **failed** in a sector-weighted vote wilt 2.999 in favor.



Alex Stern, Exelon, having voted against the motion to defer, moved to reconsider the failed motion to defer. Jason Barker, Vitol, seconded the motion. The motion to reconsider was **approved** in a sector-weighted vote with 4.084 in favor. Therefore, voting on the proposed Manual 14H revisions was deferred until the committee's next meeting.

### 2. DR Availability Window

Pat Bruno reviewed two proposed solution packages addressing the DR Availability Window issue as endorsed by the Market Implementation Committee (MIC). He indicated that based on endorsement voting at the MIC, the PJM Package with implementation in the 2027/2028 Delivery Year was the Main Motion and the PJM Package with implementation in the 2026/2027 Delivery Year was the Alternative Motion. The committee was asked to endorse a proposed solution package and corresponding Reliability Assurance Agreement (RAA) revisions upon first read.

Following discussion, the Main Motion (2027/2028 Delivery Year implementation) was **endorsed** in a sector-weighted vote with 3.707 in favor. Lisa Drauschak indicated that same day endorsement would be sought at the Members Committee. <u>Issue Tracking: DR Availability Window</u>

### 3. ELCC Accreditation Methodology

- A. Michele Greening provided an update regarding the activities of the Effective Load Carrying Capability Senior Task Force (ELCCSTF) and corresponding voting results.
- B. Pat Bruno reviewed proposed solution packages addressing two sets of reforms:
  - 1) ELCC Classes Main Motion Package A seeks to update ELCC Classes utilized in the ELCC Accreditation Methodology, and
  - 2.) BRA to Incremental Auctions (IA) Risk Mitigation, Main Motion Package B and Alternate Motion – Package C, seek to provide greater certainty in ELCC Accreditation between the BRA and final ELCC values determined for a delivery year.

The committee will be asked to endorse a proposed solution package for each set of reforms and corresponding Reliability Assurance Agreement (RAA) revisions at its next meeting. Same day endorsement will be sought at the Members Committee.
