Administration

Lisa Drauschak and David Anders welcomed stakeholders and provided the Anti-trust, Code of Conduct, and Meeting Participation announcements.

Lisa Drauschak noted that Paul McGlynn, PJM Vice President – Planning, plans to retire on March 31, 2025. She congratulated him on his service to PJM, and wished him well in his next chapter.

Lisa Drauschak noted that PJM continues to review the Trump Administration's announcement related to tariffs on imports from Canada. PJM has no direct electricity imports from Canada, but some limited amount of power originating in Canada is wheeled to PJM through other ISOs. Market participants who elect to schedule these types of transactions would be considered the importer of record and responsible for any applicable tariff. PJM will continue to monitor the situation and update the membership if circumstances change.

Endorsements

1. Manual 14H Site Control Revisions

AJ Lambert provided an update regarding the recently filed settlement proposed in Docket EL25-22 ([Site Control Filing](#)). John Miller, NedPower Mount Storm, LLC, moved and Tom Hoatson, Rolling Hills Generating, LLC, seconded deferring voting on these proposed revisions until the shorter of 60 days or receipt of FERC approval

of the proposed settlement. The motion to defer voting on the proposed revisions was **approved** by acclamation with no objections or abstentions.

2. ELCC Accreditation Methodology

Pat Bruno reviewed proposed solution packages addressing two sets of reforms:

- A. ELCC Classes Main Motion – Package A seeks to update ELCC Classes utilized in the ELCC Accreditation Methodology, and
- B. BRA to Incremental Auction (IA) Risk Mitigation, Main Motion – Package B and Alternate Motion – Package C, seek to provide greater certainty in ELCC Accreditation between the BRA and final ELCC values determined for a delivery year.

Following discussion, the following actions were taken:

- A. The ELCC Classes Main Motion – Package A was **endorsed** by acclamation with no objections or abstentions.
- B. BRA to IA Risk Mitigation, Main Motion – Package B **failed** in a sector-weighted vote with 2.753 in favor.

BRA to IA Risk Mitigation, Alternate Motion – Package C **failed** in a sector-weighted vote with 3.304 in favor.

Bruce Campbell, Mid-Atlantic Power Partners, moved and Chuck Dugan, East Kentucky Power Cooperative, seconded a motion to reconsider the vote on the Alternate Motion (Package C).

The motion to reconsider was **approved** by acclamation with no objections or abstentions.

On reconsideration, the Alternate Motion – Package C was **endorsed** in a sector-weighted vote with 4.036 in favor.

Lisa Drauschak noted that same day endorsement will be sought at the Members Committee (MC).

3. Manual 14H Surplus Interconnection Service Revisions

Ed Franks reviewed conforming revisions to Manual 14H: New Service Requests Cycle Process addressing Surplus Interconnection Service, per FERC Docket No. ER25-778. Following discussion, the proposed revisions were **endorsed** by acclamation with no objections and 40 abstentions.

4. 2026/2027 Installed Reserve Margin (IRM) and Forecast Pool Requirement (FPR) Values

Patricio Rocha Garrido provided an update on the 2026/2027 Reliability Pricing Model (RPM) IRM and FPR values. Following discussion, the proposed values were **endorsed** upon first read by acclamation with no objections or abstentions.

Lisa Drauschak noted that same day endorsement will be sought at the Members Committee (MC).

5. Deactivation Enhancements Sr. Task Force Update (DESTF)

Chen Lu reviewed proposed amendments to the DESTF Issue Charge as noted in FERC Docket No. ER25-682. David Scarpignato, Calpine, proposed an amendment to the proposed Issue Charge update to add a new Key Work Activity to provide education regarding supply resource investment and retention impacts under different methods of incorporation of RMR resources in the capacity market construct. Chen Lu accepted this proposed amendment, and therefore it was incorporated into the proposed Issue Charge update. Following discussion, the proposed update to the Issue Charge was **approved** upon first read by in a sector-weighted vote with 4.238 in favor.

6. Black Start Base Formula Rate

Glen Boyle reviewed a proposed solution package addressing the black start base formula rate and corresponding Tariff Schedule 6A revisions. The committee will be asked to endorse the proposed solution and corresponding Tariff revisions at its next meeting. Same day endorsement will be sought at the Members Committee.
