2. Black Start Base Formula Rate

Glen Boyle reviewed a proposed solution package addressing the black start base formula rate and corresponding Tariff Schedule 6A revisions. Following discussion, the proposed solution and Tariff revisions were **endorsed** in a sector-weighted vote with 4.027 in favor.
