2. ELCC Data Transparency and CETL

- A. Josh Bruno reviewed a proposed solution package addressing data transparency reforms and corresponding manual revisions. Responding to questions, Daniel Vinnick noted that a PJM statement would be posted on pjm.com with the materials for this meeting concerning provisions of the draft manual revisions related to sharing eDART data with current resource owners. Following discussion, the committee **endorsed** the data transparency solution and corresponding manual revisions by acclamation with no objections or abstentions.
- B. Tom Hoatson, Rolling Hills Generating, LLC, moved and Adrien Ford, Constellation Energy Generation, LLC, seconded a motion to defer consideration of the ELCCSTF CETL Issue Charge until such time as the stakeholders undertake consideration of a seasonal capacity construct. Following discussion, the committee <u>endorsed</u> the motion to defer in a sector-weighted vote with 3.699 in favor.

5. Operating Reserves Clarification

Lisa Morelli reviewed the PJM/IMM proposal regarding Operating Reserve Credit Reform. The committee will be asked to endorse the proposed solution and corresponding Tariff revisions at its next meeting.

6. Manuals

A. Logan Fetterhoff reviewed revisions to Manual 12: Balancing Operations resulting from its periodic review and conforming to the FERC Order (Docket # ER25-1095) addressing market rules around hybrid resources. The committee will be asked to endorse these revisions at its next meeting.
