4. ELCC Accreditation Methodology

- C. Michael Cocco, ODEC, moved and John Rohrbach, SMECO, seconded a proposed alternative solution (Package F).
- D. Bill Fields, MD Office of the Peoples' Counsel, moved, and Ruth Ann Price, DE Division of the Public Advocate seconded a proposed alternative solution (Package B1).

Following discussion, the main motion **failed** in a sector-weighted vote with 1.533 in favor. Package F **failed** in a sector-weighted vote with 3.150 in favor. Package B1 also **failed** in a sector-weighted vote with 1.791 in favor.
