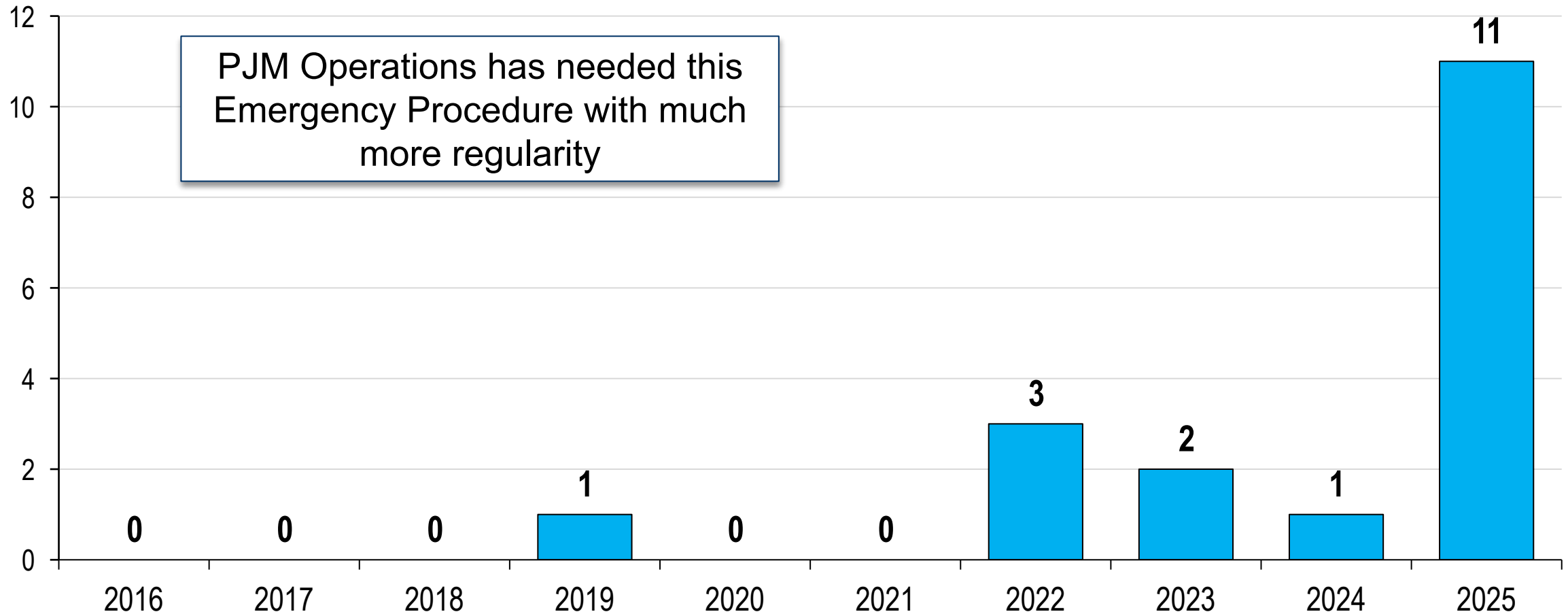


PJM Manual 14H: New Service Requests Cycle Process v3 Revision Summary

- M-14H section 4.10.1 “Interim Deliverability Studies” added additional language that will allow for the additional possibility for energy-only operation under certain conditions prior to the required network upgrades for the new interconnection generation is completed.

- 4.10.1.2 “Schedule for Interim Deliverability Studies” edited:
 - “Requests **inclusive of project name, location, Project Identifier and requested study output megawatt** for interim deliverability studies for a particular delivery year shall be made a minimum of **ten eleven** months prior to the start of that delivery year.”
 - NOTE: This is a change reflecting a friendly amendment prior to the PC endorsement
- 4.10.1.3 “Analysis for Interim Deliverability Studies” added:
 - **At PJM’s discretion, PJM may allow Provisional Interconnection Service for projects with Contingent Facilities to operate as energy-only resources for a particular Delivery Year. During such periods, PJM reserves the right to deny Provisional Interconnection Service for projects or to limit total injections for projects consistent with the results of the interim deliverability study (which may be less than the Maximum Facility Output).**
 - **The interim deliverability study shall include any additional studies necessary to evaluate a New Services Requests eligibility for Provisional Interconnection Service.**

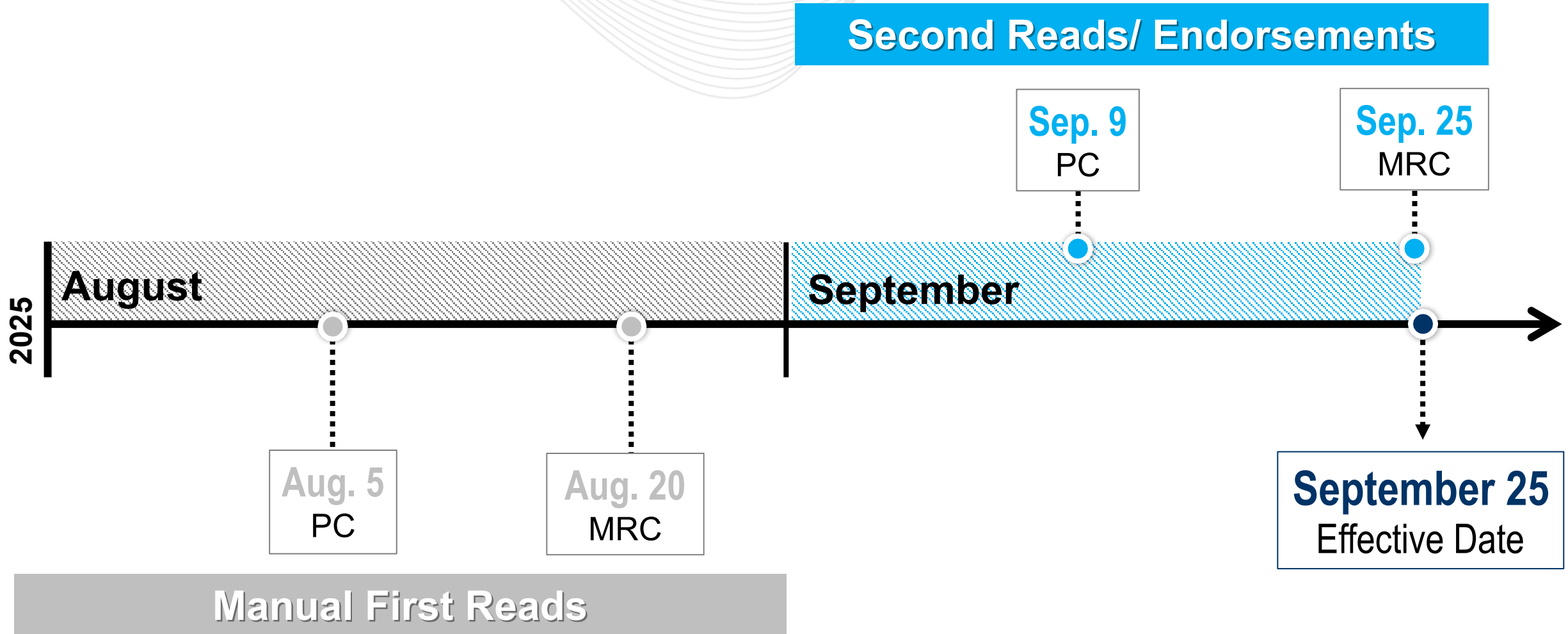
- 4.10.1.3 “Analysis for Interim Deliverability Studies” note added:
 - Even if a project is found to be deliverable or granted Provisional Interconnection Service for a particular delivery year, interim deliverability must be requested for each additional Delivery Year that the conditions apply. An energy-only resource is eligible for Provisional Interconnection Service but not awarded Capacity Interconnection Rights.

- 4.10.1.3 “Analysis for Interim Deliverability Studies” additions based on first-read feedback:
 - The Provisional Interconnection Service granted through the interim deliverability study process will be publicly posted.
 - Projects operating under Provisional Interconnection Service will be dispatched consistent with all applicable operating procedures including, but not limited to, those established in M-12 and M-14D.

- 4.10.1 changes throughout:
 - Additional cleanup to the existing language such as:
 - Inclusion of ISA as applicable
 - Capitalizing terms
 - Usage of correct defined terms
 - Grammatical corrections

- PJM has received all applications for the 2026/27 Delivery Year Interim Deliverability Study. At this time, due to the proposed revisions to Manual 14H, no action is required from developers who submitted requests. However, once the final Interim Deliverability Study language in Manual 14H is approved, PJM will review any impacts and, if needed, will directly contact affected developers to coordinate next steps.

- 4.10.1.2 “Schedule for Interim Deliverability Studies” edited:
 - After Legal review, PJM is proposing a friendly amendment to further clarify the additional language which was added at the PC regarding project submission data and its posting
 - “Consistent with PJM’s governing documents, requests inclusive of project name, location, Project Identifier and requested study output megawatt for interim deliverability studies for a particular delivery year shall be made a minimum of ~~ten~~ eleven months prior to the start of that delivery year.”

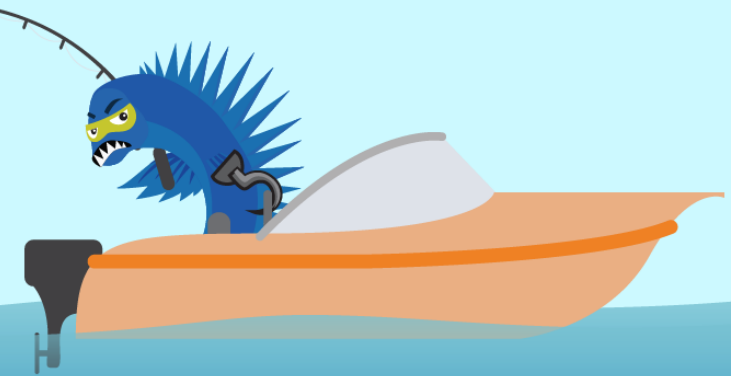
- Under Order No. 845, FERC required transmission providers to allow interconnection customers to request provisional interconnection service and operate under provisional interconnection agreements based on a readily available interconnection study and additional studies, as necessary. (See Order No. 845, 163 FERC ¶ 61,043 at PP 438 & 441 (2018))
- In PJM's Order No. 845 compliance proceeding, PJM explained that it would use interim deliverability studies to evaluate requests for provisional interconnection service. (See *PJM Interconnection, L.L.C.*, 169 FERC ¶ 61,226 at P 83 (2019))
- The *pro forma* GIA's "provisional interconnection service" provision does not limit PJM to using interim deliverability studies to evaluate requests for Provisional Interconnection Service; it also gives PJM discretion to evaluate such requests using "additional studies as necessary." (Tariff, Part IX, Subpart B, Appendix 2, section 1.4A.2)
- The Tariff, Part VII and VIII definition of "Provisional Interconnection Service" includes both capacity and energy. (Tariff, Parts VII and VIII, Definitions)
