## Endorsements

### Manual 19: Load Forecasting and Analysis

Janell Fabiano, PPL Electric Utilities Corporation, proposed amendments as posted to the proposed Manual 19 revisions to clarify that the public documentation provided by the EDC and/or LSE is limited to providing details on the load adjustment process and methodology the EDC and/or LSE used to arrive at the load adjustments in its own data submission to PJM. There were no objections to this proposed amendment and therefore it was incorporated into the main motion. Following discussion, the proposed revisions as amended were **endorsed** by acclamation with no objections and one abstention.

## 1. Minimum Capitalization

- A. Ryan Jones reviewed the main motion solution package addressing Minimum Capitalization as endorsed by the Risk Management Committee.
- B. The posted proposed amendments to the main motion were withdrawn by the proposer.

Following discussion, the main motion was **endorsed** in a sector-weighted vote with 4.383 in favor.
