- **Section 3.2.2: Market Operation Center Generation Dispatchers**
 - Minor grammatical update
 - Added clarification that training used to satisfy the PJM continuing training requirement must be relevant to PJM policies and procedures
 - Does not change the amount of annual training required
 - Topics requiring annual training will be based on the DIF (difficulty, importance, frequency) analysis and reviewed with the DTS
 - Consistent with current practice for Transmission Owner Operators

- **Section 3.2.3.1: For entities operating between 20 MW and 75 MW on an aggregate basis**
 - Added clarification that training used to satisfy the PJM continuing training requirement must be relevant to PJM policies and procedures
 - Does not change the amount of annual training required
 - Topics requiring annual training will be based on the DIF (difficulty, importance, frequency) analysis and reviewed with the DTS
 - Consistent with current practice for Transmission Owner Operators

- **Section 3.2.3.2: For entities operating less than 20 MW on an aggregate basis**
 - Minor grammatical update

- **Section 3.3: Compliance Monitoring Process for Training and Certification Requirements**
 - Added clarifications covered in prior slides to the requirement summaries listed in this section
 - Adjusted the PJM compliance monitoring process language for added clarity and consistency with other PJM manuals
 - Removed the Compliance Monitoring figure in Exhibit 2
