## Endorsements

1. 2026/2027 3<sup>rd</sup> Incremental Auction (IA) Installed Reserve Margin (IRM) and Forecast Pool Requirement (FPR) (9:10-9:35)

Josh Bruno provided an update on the 2026/2027 3<sup>rd</sup> IA IRM and FPR. Following discussion, the committee **endorsed** the IRM and FPR upon first read in a sector-weighted vote with 3.967 in favor. Same day endorsement was sought at the Members Committee.

## First Readings

### 2. Secondary Reserve Lost Opportunity Cost Offline Status Clarification

Suzanne Coyne reviewed a proposed solution related to the identification of offline generation resources for settlement purposes of Real-time Secondary Reserve Opportunity Costs. The committee will be asked to endorse the proposed solution and corresponding Manual 28 revisions at its next meeting.

### 3. Generation Self-Scheduling Market Rules

Mike Cocco, Old Dominion Electric Cooperative, reviewed a proposed Problem Statement, Issue Charge, and proposed solution seeking clarity in generation self-scheduling market rules. The committee will be asked to approve the issue charge and endorse the solution, including corresponding Manual, Operating Agreement and Tariff revisions as part of the Quick Fix process outlined in Section 8.6.1 of Manual 34 at its next meeting. During discussion on this agenda item, PJM experienced internet connectivity issues. A short recess was taken, during which no business was conducted.

- A. Ryan Nice reviewed conforming changes to Manual 03: Transmission Operations and Manual 03A: Energy Management System (EMS) Model Updates and Quality Assurance (QA) associated with FERC Order 881. The committee will be asked to endorse the proposed revisions at its next meeting.
- B. Ben Miller reviewed proposed revisions to Manual 40: Training and Certification Requirements resulting from its periodic review. The committee will be asked to endorse the proposed revisions at its next meeting.
