Administration

Lisa Drauschak and David Anders welcomed stakeholders and provided the Anti-trust, Code of Conduct, and Meeting Participation announcements.

Consent Agenda

Endorsements

1. Connect and Manage Framework Issue Charge

Chris Pulong reviewed a proposed Problem Statement and Issue Charge to address the implementation of a connect and manage framework for large load interconnections as directed in the PJM Board's January 16 CIFP-LLA decisional letter.

A hiatus was taken to allow for consideration of proposed revisions to provide clarifications as well as to incorporate provisions of the related proposed Issue Charge offered by the Data Center Coalition (agenda item three below). The committee continued discussion of remaining agenda items during the hiatus.

Following the hiatus, Chris Pulong and Pamela Quinlan discussed the proposed revisions which were incorporated in an updated Issue Charge posted on pjm.com with the materials for this meeting.

Following discussion, the Issue Charge was approved in a sector-weighted vote with 4.909 in favor.

2. Large Load Customer Connect and Manage Flexibility Issue Charge

Alex Stern and Dave Weaver, Exelon, reviewed a proposed Problem Statement and Issue Charge to address a process to provide large load customers flexibility to connect to the transmission grid in the PJM region. Following discussion, the Issue Charge was approved in a sector-weighted vote with 4.559 in favor.

3. Bring Your Own Generation Issue Charge

Pamela Quinlan, Data Center Coalition, reviewed a proposed Proposed Problem Statement and Issue Charge to address a framework to Bring Your Own Generation. Given the approval of the revised Issue Charge in agenda item 1, she withdrew the Data Center Coalition’s proposed Issue Charge.

4. Load Management and Price Responsive Demand Event Performance

Pete Langbein reviewed a proposed solution and corresponding Tariff and Reliability Assurance Agreement (RAA) revisions addressing the proposed solution on load management and price responsive demand event performance as endorsed by the Market Implementation Committee. The committee will be asked to endorse the proposed solution and corresponding Tariff and RAA revisions at its next meeting. Same day endorsement may be sought at the Members Committee meeting.
