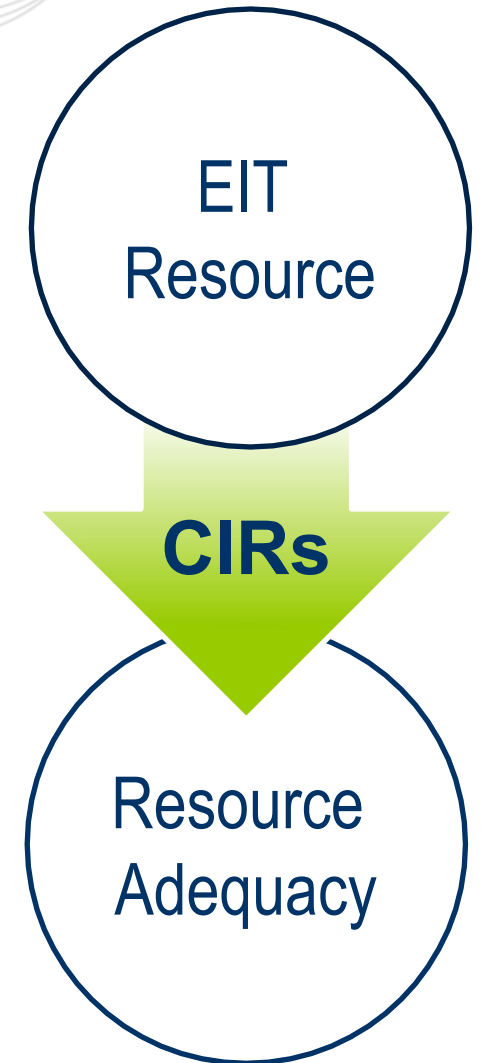
## A new temporary expedited interconnection process for generators that meet specific eligibility requirements.

To be eligible, a generator must meet the following criteria, including but not limited to:

1. Have written support from a Primary Siting Authority to expedite consideration of applicable siting
2. Be able to achieve commercial operation within 36 months
3. Have at least 250 MW of Accredited UCAP

- Standalone process that operates outside of, but in parallel to, the PJM Cycle Process

- Expedites shovel ready state sponsored generation projects to help meet future resource adequacy needs



## August 2025

PJM Board initiates the Critical Issue Fast Path (CIFP) process to address the development of reliability focused solutions for large load additions

2025

## November 2025

MC votes on solution packages presented throughout the CIFP, no consensus is made

## January 16, 2026

PJM Board delivers a letter directing PJM staff to advance seven directives, one of which being the EIT

2026

## February 27, 2026

PJM submits EIT filing with FERC. Docket No. ER26-1563

## June 9, 2026

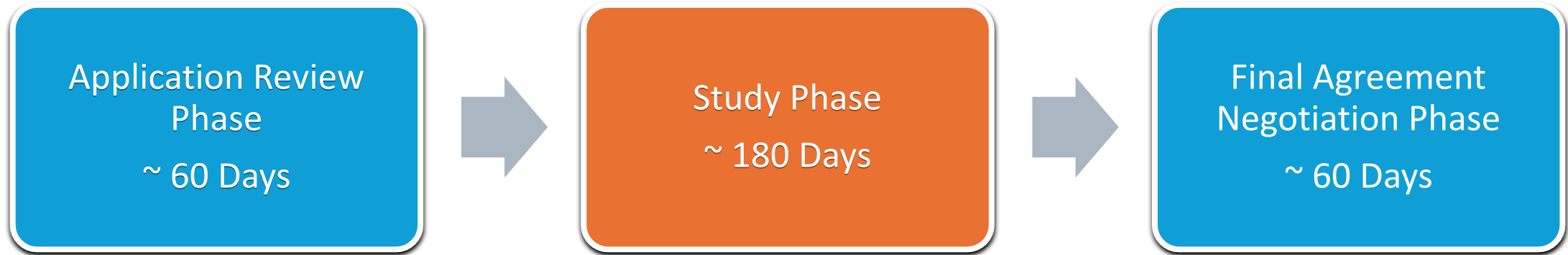
FERC accepts the EIT Tariff revisions

## April 9, 2026

PJM submits Limited Answer and Amendment with FERC Docket No. ER26-1563

## July 31, 2026

Effective Date

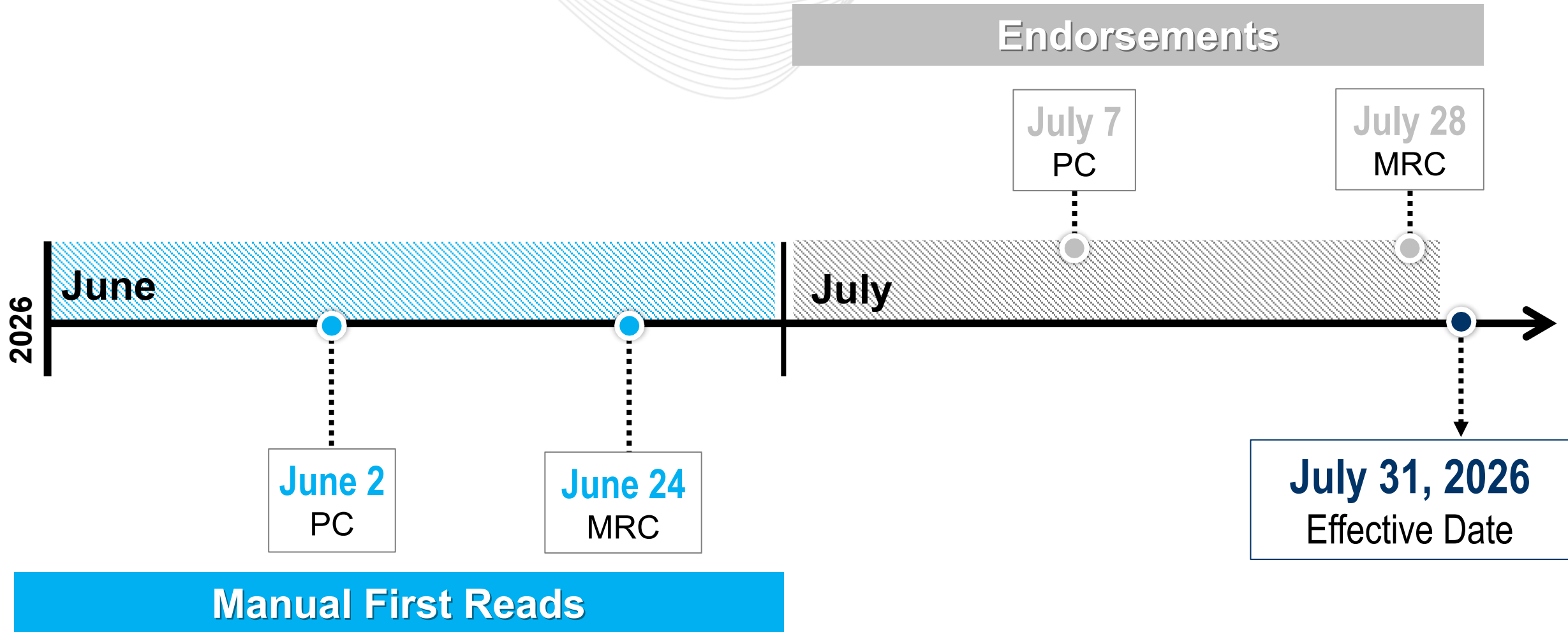

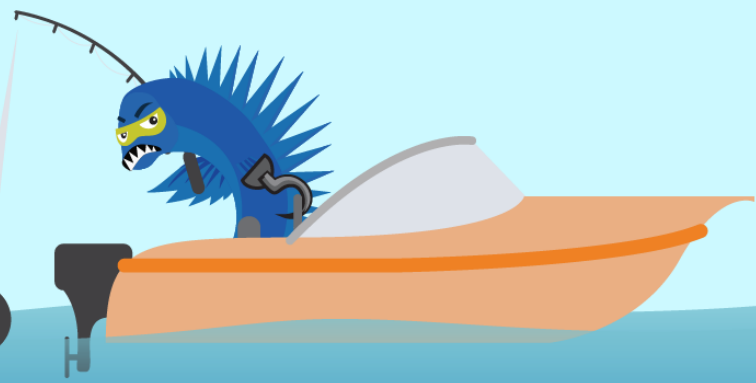
