Administration

Lisa Drauschak and David Anders welcomed stakeholders and provided the Anti-trust, Code of Conduct, and Meeting Participation announcements.

Consent Agenda

Items A and B were **approved/endorsed** by acclamation with no objections or abstentions:

- A. Minutes of the July 28, 2026 meeting of the Markets and Reliability Committee (MRC).
- B. Proposed revisions to Manual 14H: New Service Requests Cycle Process addressing the adoption of IEEE-2800 requirements.

Endorsement

1. Periodic Review of Gross CONE and Gross ACR Default Values

- A. Pete Langbein reviewed the current process and proposed default Gross CONE values used for MOPR purposes.
- B. Andrew Thompson, Brattle Group, reviewed proposed default Gross ACR values used for MOPR and market seller offer cap ("MSOC") purposes.

Following discussion, the committee **endorsed** the proposed default Gross CONE values used for MOPR purposes and proposed default Gross ACR values used for MOPR and market seller offer cap ("MSOC") purposes in an advisory vote by acclamation with no objections and one abstention. Lisa Drauschak noted that a same day advisory vote would be sought at the Members Committee.

2. Planning Parameter Deadline Reform

Andrew Gledhill reviewed a Problem Statement, Issue Charge, and proposed solution and corresponding Tariff, Reliability Assurance Agreement (RAA), and Manual 18: PJM Capacity Market revisions addressing planning parameter deadline reform. Following discussion, the committee **approved** the issue charge and **endorsed** the proposed solution and corresponding Tariff, RAA, and Manual 18 revisions as part of the Quick Fix process outlined in Section 8.6.1 of Manual 34 by acclamation with no objections and one abstention. Lisa Drauschak noted that same day endorsement would be sought at the Members Committee.

3. IRM / FPR Results for 2029/2030 Base Residual Auction

Patricio Rocha-Garrido provided an update on the 2029/2030 Base Residual Auction (BRA) Installed Reserve Margin (IRM) and Forecast Pool Requirement (FPR). Following discussion, the committee **endorsed** the IRM and FPR upon first read by acclamation with seven objections and four abstentions. Lisa Drauschak noted that same day endorsement would be sought at the Members Committee.

4. Cluster-based Interim Deliverability Study Methodology

Mojtaba Hoshmand reviewed proposed revisions to Manual 14H: New Service Requests Cycle Process addressing enhancements to the cluster-based interim deliverability study methodology. Following discussion, the committee **endorsed** the proposed Manual revisions upon first read by acclamation with no objections and six abstentions.

5. Fuel Cost Policy Clarifications for Affiliated Fuel Suppliers

A. David Hauske reviewed the PJM proposed solution and corresponding Manual 15: Cost Development Guidelines revisions regarding Fuel Cost Policy Clarifications for Affiliated Fuel Suppliers.

B. Jeremy Carpenter, Tenaska, reviewed the alternative Tenaska proposal.

The committee will be asked to endorse a proposed solution at its next meeting.

B. Christian McDowell, American Municipal Power (AMP), moved and the Borough of Chambersburg seconded the AMP proposal as an alternative proposed solution.

On behalf of MD Office of the Peoples' Counsel and NJ Division of the Ratepayer Advocate Greg Poulos moved and seconded IMM proposal B.3 as an additional alternative proposed solution. Catherine Tyler, Monitoring Analytics, presented the IMM proposal.

The committee will be asked to endorse a proposed solution at its next meeting.

The committee will be asked to endorse the proposed revisions at its next meeting.
