Appendix

- 1: “Response by Total Resource (MW)” is the performance based on each resource that has a reserve assignment where the resource performance is capped at 100%.
- 2: “Netted Response by Portfolio (MW)” is the performance based on the organization’s portfolio where performance is netted across all resources that have a reserve assignment for each organization. This allows an over-performing resource to offset an under-performing resource within the same organization. Each organization’s performance is capped at 100%. This reflects the way penalties are administered.
