**Reason for change:**

  - Revised and updated guidance for DLR owners and 10-day window requirements
- 2.1.2, Short Term Emergency Ratings
  - Changes PJM's "Transmission Facility Ratings Database" to eDART TERM from M03 Attachment F as source for facilities with distinct STE from LTE

- 3.3, PJM Transmission Facility Ratings Database
  - Defines the new AAR Facility Ratings Database
  - Default duration for each rating type (Long-term, etc.)
- 3.3.1, Conditional Ratings (new)
  - New conditional rating tables and related new requirements
- 3.3.2, TO SCADA Zone and AAR Transmission Facility Mapping (new)
  - Definition for new TO SCADA Zones (AAR thermal regions)
- 3.3.3, AAR Ambient Conditions (new)
  - Describes the hourly/seasonal ambient conditions to be applied
- 3.3.4, Rating Set Hourly and Seasonal Derivation (new)
  - Sets requirements for hourly for next 10 days. Seasonal for next 24 months.

  - Data included in eDART for AARs
