- 1. Megan Heater, PJM, called the meeting to order. Ashwini Bhat, PJM, reviewed the Anti-trust, Code of Conduct, Media Participation Guidelines, and the Webex and In-person Meeting Participation Guidelines.

3. Manual 14H – Interim Deliverability Study Procedures

Donnie Bielak, PJM, provided a second read of the Quick Fix Issue Charge and Problem Statement for revisions to Manual 14H regarding Interim Deliverability Study Procedures. The Planning Committee **approved** the Issue Charge and **endorsed** the proposed solution addressing Interim Deliverability Study Procedures, as amended, with 164 (93.2%) in favor, 12 (6.8%) opposed, and 0 abstentions. A second vote showed stakeholders preferred the proposed solution, as amended, over status quo, with 100% in favor, 0 opposed, and 11 abstentions.

4. Expansion of Provisional Services

Jason Shoemaker, PJM, provided a second read of the Issue Charge and Problem Statement to explore the expansion of Provisional Service to permit projects, under certain circumstances, to safely and reliably generate power on an energy-only basis prior to the completion of certain interconnection studies. The Planning Committee **approved** the Issue Charge by acclamation with 0 objections and 0 abstentions.
