 - 2026 Series Load Flow
 - TOs to provide Trial 3 feedback via idv by February 11th.
 - PJM's Transmission Modeling group will deliver cases to PJM's Transmission Planning for review by early March.
 - 2026 Series Short Circuit
 - PJM to provide Trial 3 of the 2-year case and Trial 1 of the 5-year case by February 13th.
 - TOs to provide feedback by February 27th.
- MMWG
 - 2025 Series Dynamics
 - PJM updated MMWG SDDb database with additional dynamics data for Trial 0.
 - PJM finished no-fault and disturbance tests for all MMWG dynamics cases.
 - PJM provided idevs for dynamic corrections to PowerTech.
- PJM will open the annual Gen Model window for Generation Owner data on May 1st. The window will remain open for 45 calendar days, through June 15th.
 - Generator Owners are expected to submit all required data within window through the Gen Model platform.
 - New fields added to Gen Model for the 2026 window for Generator Owners to provide:
 - Factory Acceptance Test (FAT) report for each transformer – PDF upload
 - Protection Information – Dyr file upload, applicable only to IBR
 - Conventional generators that do not own any circuit breaker and previously left the breaker/relay section blank are now required to enter protection information.
 - New section added for Generator Owner review:
 - Facility one-line, along with its modeling data (.idv/.raw)
