5. Manual 21B Periodic Review

Joshua Bruno, PJM, provided updates on Manual 21B: PJM Rules and Procedures for Determination of Generating Capability as part of its periodic review. Rebecca Stadelmeyer, Morris Cogeneration, motioned to defer the vote to the next PC meeting and Paul Sotkiewicz, Elwood Energy, seconded. **The committee endorsed the deferral by acclamation with 0 objections and 0 abstentions.**

6. Manual 14H Revisions: Cluster-Based Interim Deliverability Study

Mojtaba Hoshmand, PJM, provided an update on Manual 14H: New Service Requests Cycle Process regarding enhancements to the cluster-based interim deliverability study methodology. **The committee approved the Issue Charge and endorsed the solution concept as part of the Quick Fix process outlined in Section 8.8.1 of Manual 34 by acclamation with 5 objections and 0 abstentions.**
