Election of candidates for the Board of Managers is conducted at the Annual Meeting each year (OA, section 7.7).

The election is conducted by secret ballot (Manual 34, section 11.11).

- Members' expressed preference is that PJM not have access to see their ballots.
- PJM investigated a third-party solution for Board elections that ensures continued confidentiality and secure sector-weighted voting results for future Board elections beginning in 2021.

Before Election

Eligible voters must meet participant criteria by May 1, 2025, 5 p.m. EST.

Criteria required:

1. MC Roster Representation

2. Voting read/write access in account manager

- Voting links with instructions will be emailed to eligible voters by Survey and Ballot Systems (SBS).

- One link for each Voting Member company rostered

During Election

- SBS provides voter support.
 - Election closes after 15 minutes (only after any voter issues are resolved by SBS).

- Only one ballot will be accepted per Voting Member company.

After Election

- Results reported within one hour at MC.

Survey and Ballot Systems sends voting links to eligible voters.

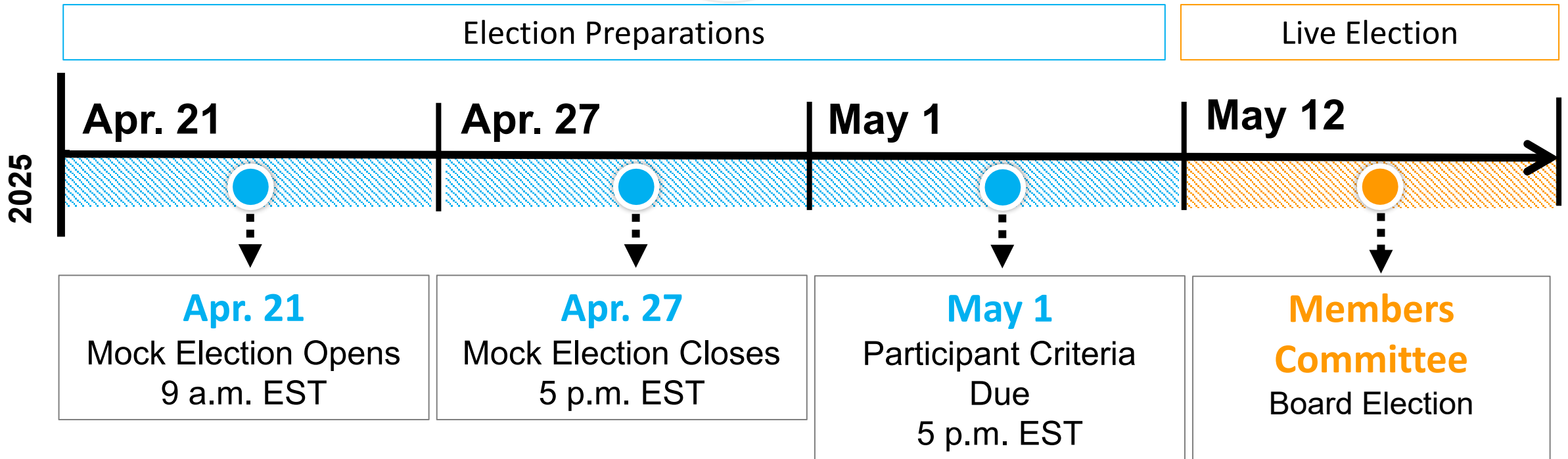

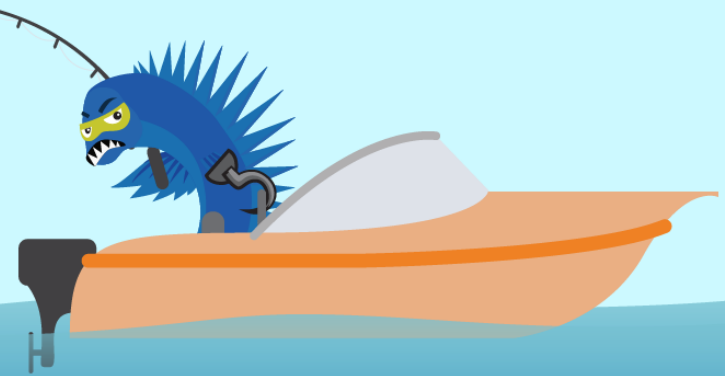
