








## 2025 eDART Roadmap







### eDART Maintenance Release (Prod & Train: January 29, 2025)

- Modifications to the eDART UI XML upload response page to display error messages returned until closed by the user.
- Adding an error message to Current & Future and Historical reports when:
  - Ticket ID is not entered or Company/Zone not entered
- Internal administrative and backend changes

## Upcoming eDART Release

#### eDART Release (Train: February 26, 2025; Prod: March 12, 2025 1:00-5:00 p.m.)

- •• Update to the Transmission Facility Outages List (linesout.txt) to support the Transmission Outage Information Transparency Initiative
  - •• Provide a timestamp when a ticket was last evaluated by PJM in the 6 Month Out to 2 Day Out period; or, when the status of the At Risk flag was changed
  - •• Include a field to indicate if a transmission outage ticket is considered 'On-Time
- •• Corresponding updates to the TOIMWG download file, XML and UI
  - •• <lastEvaluated> timestamp with format = mm/dd/yyyy hh24:mm
  - •• <onTime> with 'Yes' or 'No' values

Release Notes <u>eDART XML Schemas</u>



Revisions to the *pro forma* Open Access Transmission Tariff (OATT) and the Commission's regulations under the Federal Power Act to improve accuracy and transparency of electric transmission line ratings.

- Impacts eDART TERM Application and pjm.com OASIS thermal ratings reports
- Recent Implementation highlights
  - eDART XML documents page updated
  - eDART TERM application UI updated
  - TERM user access modifications
  - Renamed eDART Public Files to PJM Posting Files



### eDART FERC Order 881 key takeaways:

- FERC 881 enhancements are available in eDART Train only.
- The UI has been updated to reflect 881 functionality.
- The CLI to temporarily support current and 881 functionality.
- Current ratings data (pre-881) will be stale and TERM endpoints not valid post-881 will be retired; retirement date to be announced.
- XMLs are in progress and will be communicated as delivered.
- We will be scheduling a special eDART Forum meeting to review the new 881 enhancements
