## eDART Maintenance Release (Train July 16, 2025; Prod July 23, 2025)

- Enhancement to include RTEP Queue Information in Projects
  - Ability to add RTEP Queue # on creation and edit of Transmission Projects
    - Accepted format for RTEP Queue IDs: XXXXX.YYYY (max 5 characters before period and max 4 after)
  - Up to ten RTEP IDs can be associated with each project (optional boxes)
  - Ability to search by RTEP Queue # (optional field)
- Max of 4 RTEP Queue #s per transmission ticket (comma separated or semi-comma separated)

## eDART Maintenance Release (Train July 16, 2025; Prod July 23, 2025)

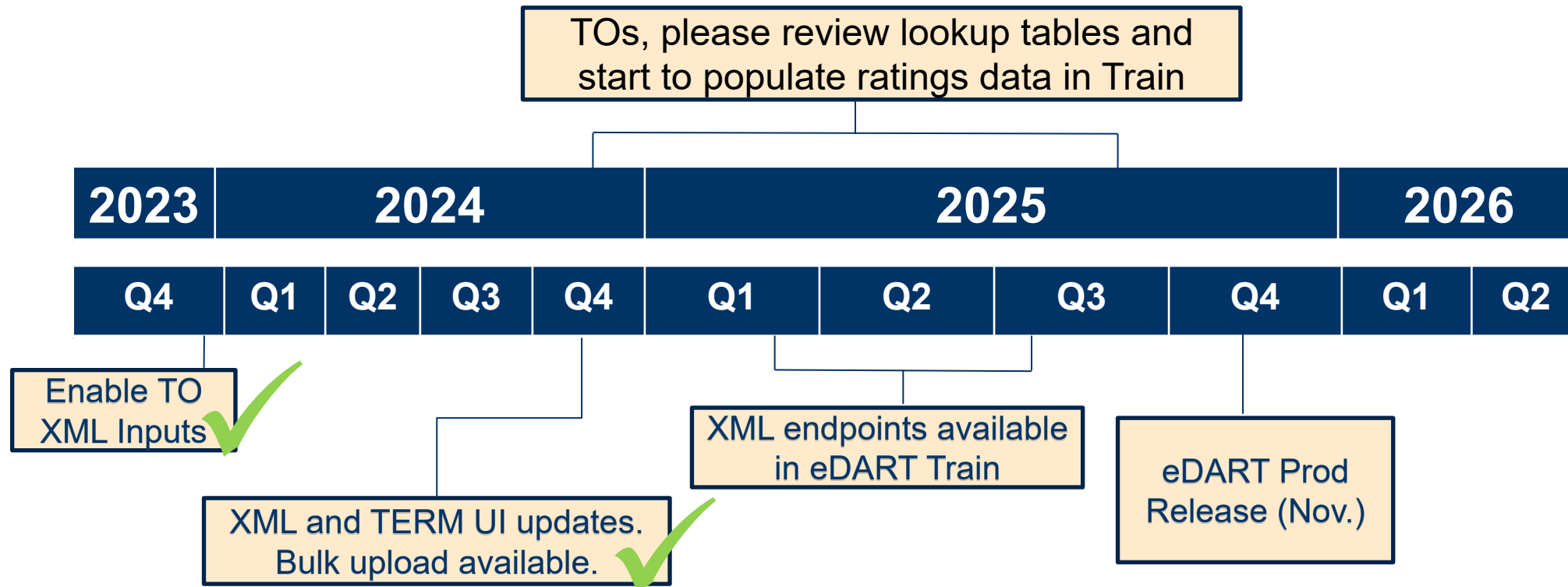
- Updates for Normally Open equipment (Takeout and Restore)
  - Normally open equipment can no longer be used for Takeout/Restore on Transmission tickets
    - Error message will be returned on the attempted submission
    - If needed, N.O. equipment can be added as outaged equipment on the ticket and scheduled accordingly

- The CLI to temporarily support current and 881 functionality.
