- Daily Generation capacity feed enhancement
 - Update the data to correct a date conversion issue with the feed posting
 - Enhance the data to include only available generation MWs
 - After the changes have been applied, the entire data posted including historic data will be refreshed.
- Feed changes for FERC Order 881
 - Retiring Day ahead temperature sets feed



Security Protocol Upgrade – Full Deployment

The security upgrade rolled out on 9/16/2025 identified few of our API users whose systems/software was not compliant to the upgrades made. PJM turned off few features to allow these users to test and adjust their software.

- Full set of features will be turned back in Q1 2026
- The full solution is available in Data Miner train to test the connectivity and compliance
- Following standards are mandatory to be able to connect to Data Miner API
 after the full roll out
 - TLS 1.2 with ciphers
 - Operating systems and software that have not reached End of Life Cycles

 Up to one million rows. API Up to 50K Rows per fetch

1	Data update	'RTO Regulation Performance' with type 'Price' renamed to 'RTO Regulation Mileage' 'RTO Mileage Ratio' with type 'Ratio' redefined to equal 5-Min Actual Mileage / Historical (Daily) Mileage



PJM is referring to Data Miner 2 as simply "Data Miner". This change is being made incrementally across various tools, documentation, and pjm.com. This is simply a change for convenience.

No technical changes are required. (For example, URLs remain unchanged)



eDataFeed Migration Highlights

eDataFeed migration to Data Miner

- eDataFeed data streams will be available in Data Miner from June 26, 2020 onwards. The API Guide will be updated to reflect the API short names and attributes
- Release notes will have additional information such as the feed names and descriptions
- Data for these feeds will be available on UI and API
- All feeds are made available in the beta (train) environment from June 12 onwards for testing purposes.
 Please note the data in stage is only for testing purposes and not production quality data.
- eDataFeed will tentatively retire on June 26, 2021
- Final feed list and mapping of eDataFeed to Data Miner feeds is available on the tools page


