Administration

Welcome and approval of the March 30, 2025 minutes

The Committee unanimously approved the minutes of the March 30, 2025 ISAC meeting.

Announcements

 Updated ISAC Schedule – OPSI discussed the updated ISAC meeting schedule for the rest of 2025 which tries to schedule most ISAC's the Monday after the TEAC each month.

Discussion Items, (3:00 – 4:00)

1. TEAC Update

Susan McGill provided an update on TEAC activities, covering interregional planning, generator deactivations, market efficiency, and reliability analysis. She explained that PJM's five-year base case includes existing and signed interconnection resources, while seven-year scenarios incorporate additional queue projects to inform long-lead planning.

2. PSEG Letter to PJM Board of Directors

Jodi Moskowitz and Ed Gray of PSEG discussed their recent letter to the PJM Board of Directors. They emphasized PSEG's growing concern over PJM's reliance on suspended generation to solve reliability cases. With more than 12,000 MW of suspended resources appearing in scenario modeling, they argued this highlighted a broader resource adequacy crisis. They urged PJM to work more closely with states to ensure planning reflects realistic supply and demand conditions and to avoid misallocating transmission investment toward projects tied to generation that may not materialize.

3. Role of ISAC Workbook in Order 1920

Matt Bernstein, PJM, provided an update on how PJM is adapting the ISAC State Policy Workbook to support long-term scenario planning under FERC Order No. 1920. He previewed a new structure for categorizing policies within the workbook and explained how this structure could guide scenario development. PJM intends to coordinate with PARSEC on future workbook iterations, including potential differentiation between near- and long-term policy tracking tools. Commissioner McCabe noted the overlap between ISAC and PARSEC membership should help facilitate that coordination.
