## **Discussion Items. (3:00 – 4:00)**

### **1. TEAC Update**

Susan McGill reviewed the distinctions between baseline, supplemental, and network projects, the separation of regional and local needs, and how large load additions are addressed through both local “do no harm” reviews and PJM’s regional forecasting. She noted the status of the 2024/25 Long-Term Market Efficiency Window 1, including the range of project proposals received, and gave brief updates on small deactivations, supplemental projects driven by large loads, and the initial screening of 2025 RTEP Window 1 needs. She also described scenario analysis on the potential impacts of delayed offshore wind projects and the addition of new PPL zone loads not yet included in the official load forecast.

### **2. PPL Future Load Information**

Susan McGill discussed recent load growth information PJM had provided in its 2025 RTEP window for the PPL zone and explained how this new information was being used to inform the evaluation of reliability projects.

### **3. ISAC/PARSEC Consolidation**

Ben Sloan, OPSI, reviewed the similarities and differences between the ISAC and PARSEC, describing potential efficiencies and challenges associated with combining the two groups. He also provided background on the foundational FERC orders that led to their creation.
