<u>Discussion Items. (3:00 – 4:00)</u>

1. Provisional Interconnection Service

Jason Shoemaker of PJM presented on recent conversations related to the expansion of Provisional Service to permit projects to interconnect on an energy-only basis prior to the completion of certain interconnection studies. He explained this initiative involves both a "quick fix" manual update and a longer-term stakeholder process to provide operational flexibility as system conditions tighten.

2. PJM-MISO Interregional Study Update

Mark Sims of PJM provided a brief update on PJM and MISO's recent interregional study work and discussed identified potential transmission solutions and next steps. The joint study combined reliability, transfer, and economic analyses, which identified overlapping needs and opportunities to address limiting facilities on the seam between the two systems. He also discussed potential governing document changes that may be necessary to enable projects that expand interregional transfer capability.

3. TEAC Update
