Administration

Welcome and approval of the October 27, 2025

The ISAC approved the minutes by acclamation.

Announcements

Ben Sloan shared the 2026 ISAC meeting schedule. These meeting primarily fall on the second Monday of each month with a few exceptions.

Discussion Items. (3:00 – 4:00)

1. Review of ISAC Workbook

Ben Sloan, OPSI, walked through tab-by-tab changes to the PJM assumptions workbook, covering updated RPS, clean energy, electrification policies, offshore wind and storage targets, siting restrictions, new gas build assumptions, siting opportunities and restrictions, IRPs, and a new large-load-tariff tab. States were asked to review their entries and send any final edits or additional explanatory notes.

2. 2025 RTEP Window 1

PJM reported receiving **134 competitive transmission proposals**, organized into three regional clusters and totaling about **\$11.6 billion** in recommended solutions, evaluated using a core reliability **scenario** plus additional scenarios to right-size projects.

3. Leadership in Grid Innovations for High-voltage Transmission for States (“LIGHTS”)

Yuri Dvorkin and Abe Silverman described a new **DOE-funded project** to help PJM states identify and evaluate grid-enhancing and advanced transmission technologies, using detailed PJM-focused modeling and a confidential request portal to support state-driven analyses. The team aims to produce practical,

near-term project assessments (prioritizing ratepayer benefits, speed, and use of existing ROW) that can inform PJM RTP windows, Order 1920 compliance, and state planning. Future collaboration is expected in 2026.
