4. Darrell Frogg, PJM, provided a verbal update on current 2025 Renewable Dispatch Data Request and Curtailment Flag. Due to on-going discussions on wind and solar dispatch at the Distributed Resources Subcommittee (DISRS), PJM will delay the retirement of the wind curtailment indicator until July 1, 2025. It is expected that all wind generation resources be able to follow PJM's dispatch signal without the wind curtailment indicator by that date.
