- The most recent tests occurred on:
 - October 14 DUQ and DEOK zones
 - October 17 DOM zone
- Next steps:
 - Retest process (if desired)
 - Test Emergency Energy Settlements
 - Compliance

- Retest (if desired) – can only determine performance once all registrations in zone are tested (annual + summer only):
 - If test reductions $> 75\%$ of commitment, CSP can self schedule retest(s) in DR Hub (must be in same season)
 - If test reductions $\leq 75\%$ of commitment, CSP has 46 days from the test date to request that PJM schedule a single retest
 - DUQ and DEOK zones – by November 29, 2025
 - DOM zone – by December 2, 2025

- Submit test **energy settlements** within 60 days of test event
 - DUQ and DEOK zones – by December 13, 2025
 - APS and AEP zones – by December 16, 2025
- CBLs
 - Generally, for DUQ and DEOK test CSP will need to upload 24 hours of daily load data for the following dates to calculate the *3 Day Types with SAA CBL*:
 - **October 7, 8, 9, 10, 13, 2025**
 - Generally, for DOM tests CSP will need to upload 24 hours of daily load data for the following dates to calculate the *3 Day Types with SAA CBL*:
 - **October 10, 13, 14, 15, 16, 2025**

- CSP Retest (initial test $> 75\%$)
 - Start/end instructions sent from DR Hub in response to normal CSP polling according to registrations' lead time
 - Email sent at notification time
- PJM Retest (initial test $\leq 75\%$)
 - Day Before PJM Retest Date:
 - Load Management/PRD Retest Summary event(s) posted to DR Hub Events section by 10:00 EPT the day before retest date
 - CSP should monitor DR Hub webpage and/or use web service function to obtain retest date
 - Since retests are CSP specific they are not posted to the Test webpage
 - Email sent by 10:00 EPT the day before retest date
 - Event Day
 - Start/end instructions sent from DR Hub in response to normal CSP polling according to registrations' lead time
 - Email sent at notification time

- Compliance will be determined after the Delivery Year
- Only registrations that have not been part of a Load Management Event during the DY will be subject to capability demonstration by test

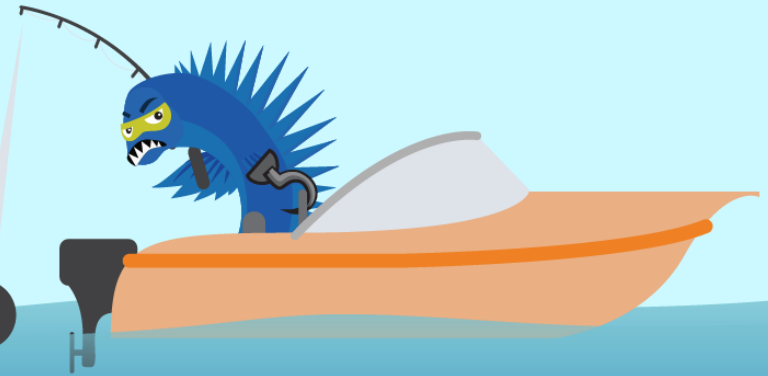
