The change of process is effective 10/15/25 and affects e-mails with attachments coming into the Training Support mailbox and those State & Member Training (S&MT) issues.

- 1. E-mails with attachments: Response, without attachments, will be provided once the requested action is complete.
- E-mails requesting Learning Management System reports: Reports will be sent via PJMs Secure Share tool.
- 3. E-mails with attachments issued by S&MT: Attachments will be sent via PJMs Secure Share tool.

PJM's Secure Share is a tool designed to aid with the transfer of files that are too large or too sensitive to be exchanged via email with external audiences. This tool allows users to share files either through secure messages or by creating and sharing secured folders. It is important to note that this tool requires the end-user to have a PJM account.
