- The current MSRS report format uses a data label column and 24 Hour Ending (HE) columns to report data.
- For consistency with other reports and PJM maintenance, the format will be updated to utilize EPT and GMT HE columns and individual data columns.



The Operating Reserve for Load Response Resource Deviations report uses 24 EPT HE columns to display data across the report.

 - Renamed to "Operating Reserve for Load Response Resource Deviations (Pre 3.1.2025)" on the MSRS Reports page and MSRS Application.
