You are receiving this email in accordance with NERC Reliability Standard PRC-023-6 R6.2. PJM, as the Planning Coordinator is required to provide the list of circuits to all Regional Entities, Reliability Coordinators, Transmission Owners, Generator Owners, and Distribution Providers within its Planning Coordinator area

- R6. Each Planning Coordinator shall conduct an assessment at least once each calendar year, with no more than 15 months between assessments, by applying the criteria in PRC-023-6, Attachment B to determine the circuits in its Planning Coordinator area for which Transmission Owners, Generator Owners, and Distribution Providers must comply with Requirements R1 through R5. The Planning Coordinator shall:
 - 6.1 Maintain a list of circuits subject to PRC-023-6 per application of Attachment B, including identification of the first calendar year in which any criterion in PRC-023-6, Attachment B applies.
 - 6.2 Provide the list of circuits to all Regional Entities, Reliability Coordinators, Transmission Owners, Generator Owners, and Distribution Providers within its Planning Coordinator area within 30 calendar days of the establishment of the initial list and within 30 calendar days of any changes to that list.

PJM would like to request all TOs, GOs & DPs to review the list and if any errors or omissions are identified, please notify PJM immediately so that we can follow up with the needed updates/corrections.
