PJM has issued a new eDART Data Request to collect emission rates data.

Generation Owners with thermal resources should work closely with their MOC/eDART contact as soon as possible to ensure responses are provided via eDART no later than 23:59 EPT on Friday, October 31, 2025.

## **Generator Emission Rates Data Request**

Attention eDART Gen. Contacts: ACTION REQUIRED FOR ALL THERMAL GENERATION RESOURCES

In accordance with PJM Manual 14-D, Generator Operational Requirements, Section 7.3.5 Fuel and Emissions Reporting, PJM is initiating a new Data Request. **This Data Request is** <u>mandatory</u> for all thermal resources.

This information is required for reliable operations planning purposes and enhanced PJM situational awareness. The last question in the Data Request is intended for Generation Owners to share any concerns that are not specifically addressed elsewhere in the survey. PJM will be utilizing this data to track run hours/starts against emissions limits. This will provide better situational awareness for dispatch to determine when a generator may be nearing its emission limit(s).

As noted above, the data request is mandatory for Generation Owners and Market Participants with thermal resources and the obligation to respond is not excused, even if a third party asset manager or other third party contractor is responsible submitting eDART data. Failure to comply with this Data Request may result in potential referral to FERC Office of Enforcement, and is potentially actionable as a violation of the Tariff, the applicable ISA, and/or Operating Agreement section 11.3.1.

The Generator Emission Rates Data Request will open in eDART on Wednesday, October 1, 2025, and will be open through 23:59 on Friday, October 31, 2025.

Please note that PJM will share all Data Request responses with its independent market monitor, Monitoring Analytics, LLC. In addition, data responses could be requested by regulators and PJM would share with member notice only in accordance with the PJM Operating Agreement, section 18.17.
