- Revisions throughout Attachment A to align Manual language with newly revised NERC Standards IRO-010 and TOP-003 (Effective 7/1/2025)

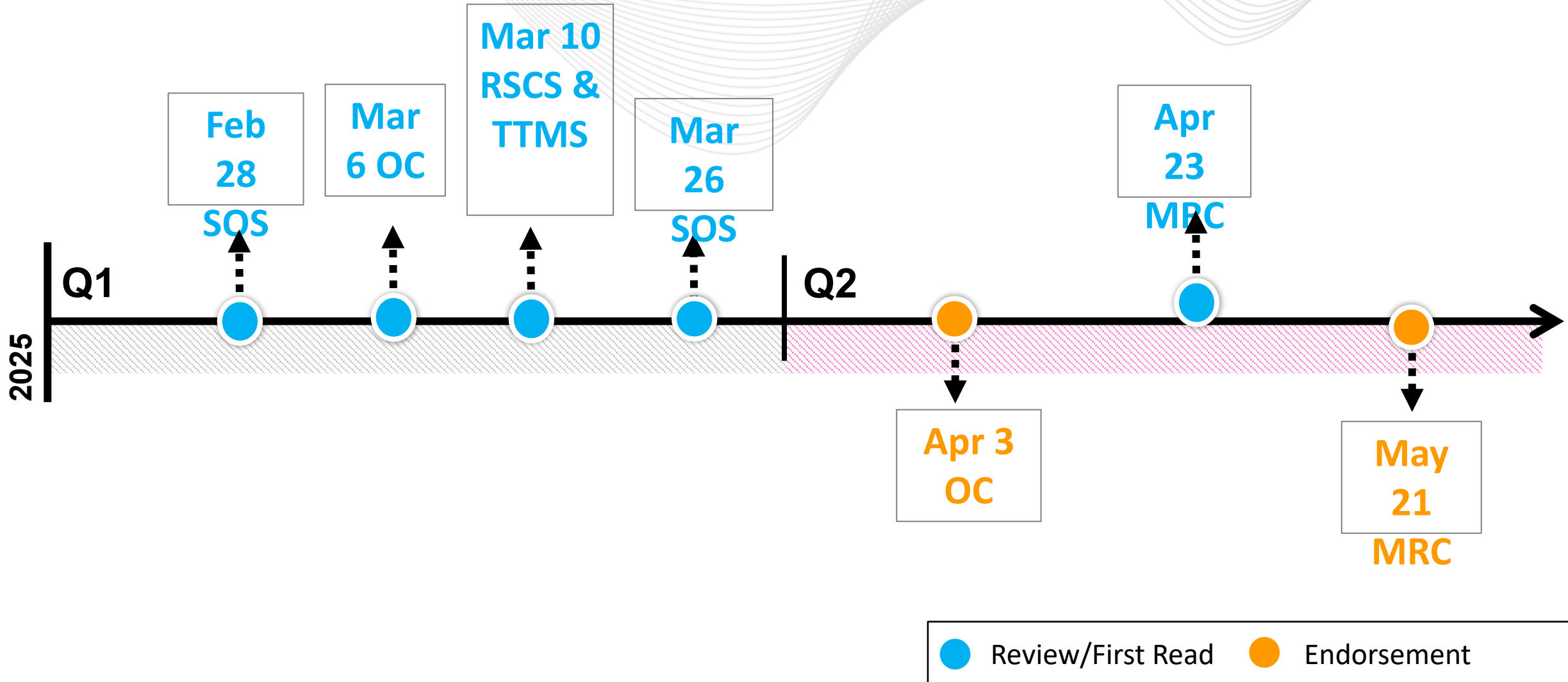
- Attachment A: Data Specification and Information Collection

As the Balancing Authority, Transmission Operator, and Reliability Coordinator, PJM has the responsibility to prevent instability, uncontrolled separation, or cascading outages that adversely impact reliability and fulfill its operational and planning responsibilities as outlined in NERC Reliability Standards IRO-010 and TOP-003~~2~~. PJM must ensure that PJM has all data and information required to monitor, assess, and perform Operational Planning Analyses of its region. This attachment lists the data and information PJM requires from PJM Members and external entities to conduct such analysis and operate the system reliably. Section 5.2 of this manual meets the performance criteria for the availability and accuracy of data and information as applicable. This attachment constitutes the data and information specification as required by IRO-010 and TOP-003 and identifies the following:

## Attachment B: Schedule of Data Submittals

- Section EOP-008 R5.1 updated Frequency of certification submittal from “Within 60 days of any changes” to “Recommended by December 31”
  - Revision is to align with NERC Standard EOP-008 and PJM TO/TOP Matrix
