- 2. The draft minutes from the October 2nd DESTF meeting were reviewed and approved by acclamation with no objections or abstentions.

Consensus Based Issue Resolution Process (9:10-12:00)

- 3. Proposal sponsors provided updates and reviewed their solution packages.
 - Michael Herman and Lisa Morelli, PJM, reviewed PJM's Solution Package (Package A).
 - Joe Bowring, IMM, reviewed IMM's Solution Package (Package B).
 - David Scarpignato, Calpine, withdrew Calpine's Solution Package (Package C).
 - Lisa Morelli, PJM, reviewed PJM's Solution Package (Package D).

The DESTF took an offline vote on the remaining proposed solutions (Packages A, B and D) following the October 17th DESTF meeting. The vote and corresponding instructions were sent via the DESTF email list. The vote results were as follows:

- PJM (Package A) failed with 88 in favor, 141 opposed and 0 abstentions
- PJM (Package A) was not preferred over status quo with 108 in favor,
 115 opposed and 6 abstentions
- IMM (Package B) failed with 7 in favor, 222 opposed and 0 abstentions
- IMM (Package B) was not preferred over status quo with 16 in favor, 213 opposed and 0 abstentions
- PJM (Package D) was endorsed with 159 in favor, 70 opposed and 0 abstentions
- PJM (Package D) was preferred over status quo with 155 in favor, 74 opposed and 0 abstentions
