3. Ian O'Neill, PJM, provided an update on how PJM is quantifying uncertainty in setting the "DASR 2.0" requirement specifically for medium and high-risk days.
4. Kevin Hatch and Emily Barrett, PJM, provided a review of PJM's reserve needs under higher risk operations and perspectives on addressing the energy gap in the day-ahead market.
