- The RCSTF will vote four packages:
 - PJM Package – Package A
 - IMM Package – Package B.1 (Uncertainty Requirements – 6 months to 1 year)
 - IMM Package – Package B.2 (No MCE Changes – Phased implementation, B.1 followed by B.2)
 - IMM Package – Package B.3 (Phased implantation, B.1 followed by B.2 followed by B.3)
- Vote is currently planned to open on June 25 at the conclusion of the RCSTF meeting and remain open until July 10, 2026 at 5 pm.
- Results will be posted to the RCSTF webpage on July 14 and the task force will be notified via the RCSTF distribution list.

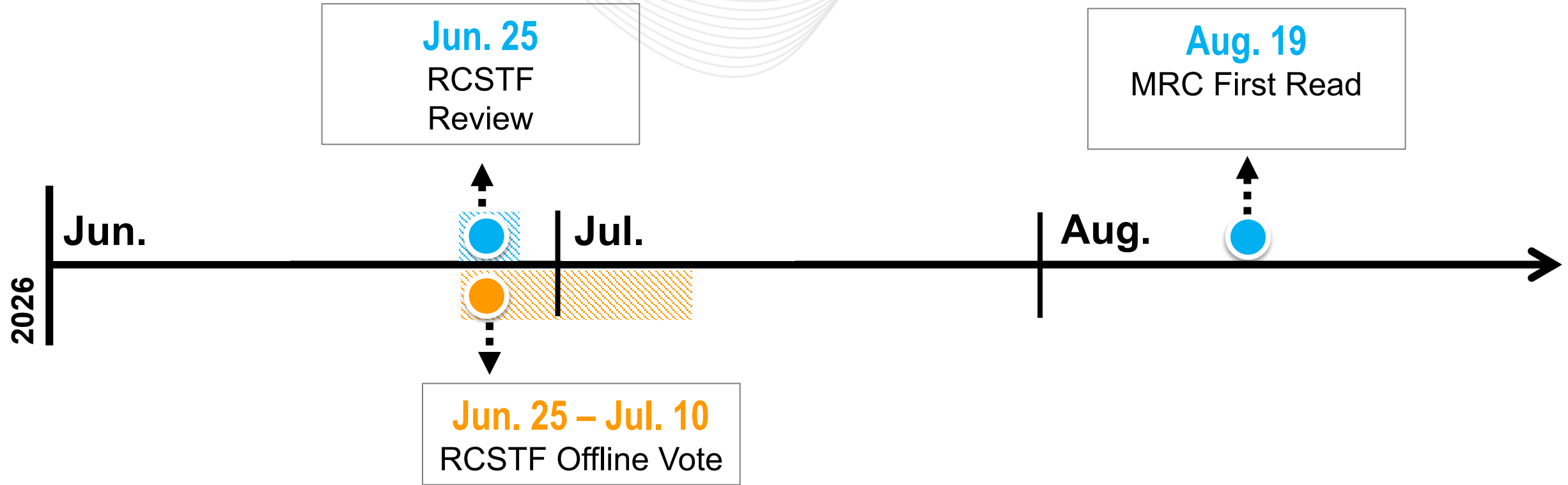

- Packages B.1, B.2 and B.3 (IMM) are inter-related but are to be voted individually, so...
 - A vote for Package B.1 is an endorsement to only implement B.1 and nothing more
 - A vote for Package B.2 is an endorsement to implement B.1 in the short-term and then B.2 in the medium-term, but then to not implement the market clearing engine changes
 - A vote for Package B.3 an endorsement to implement B.1 in the short-term and then B.2 in the medium-term and then the remainder in the long-term

- Company representatives must be on a roster in order to vote
 - Each Member is allowed 1 primary and 3 alternate representatives per committee roster
 - Only one roster representative may cast a vote on behalf of a Member
- The roster representative who will vote must have voting read/write access in order to access the Voting Application.
- Voting Members and Affiliate Members are eligible to vote.
- Voters can log in and vote or change previously submitted votes, as long as the vote remains open



Anticipated MRC and MC voting to take place in September/October.
