Re: Errata Filing in PJM Interconnection, L.L.C., Docket No. ER25-3073-000

Dear Secretary Reese:

PJM Interconnection, L.L.C. (“PJM”) submits this errata filing to correct a typographical error in its August 1, 2025 Request for Waiver in the above captioned docket. Specifically, it has come to PJM’s attention that at the bottom of the first paragraph of the waiver request, PJM inadvertently indicated that potential updates to the Cost of New Entry and modifications to the Variable Resource Requirement Curve would be effective with the 2027/2028 Delivery Year. However, as noted in the remainder of this waiver request, the upcoming Periodic Review Filing is targeted to be effective with the Base Residual Auction associated with the **2028/2029** Delivery Year, which is scheduled to commence in June of 2026. Therefore, the applicable sentence should be corrected to state: “Pursuant to Rule 207(a)(5) of the Federal Energy Regulatory Commission’s (“Commission” or “FERC”) Rules of Practice and Procedure, PJM Interconnection, L.L.C. (“PJM”) respectfully requests a prospective waiver (“Waiver Request”) of the Open Access Transmission Tariff (“Tariff”), Attachment DD, section 5.10(a) to allow for a limited extension of time for the PJM Members to vote, and for PJM to file, potential modifications to the Variable Resource Requirement Curve shape and updates to the Cost of New Entry values to be effective with the **2028/2029** Delivery Year (“Periodic Review Filing”).”
