Fifteenth and Final Informational Filing on Status of Transmission Constraint in the

Northern Neck Peninsula

Dear Secretary Reese:

In compliance with the February 18, 2022 Order of the Federal Energy Regulatory Commission ("Commission") in the above referenced proceeding, PJM Interconnection, L.L.C. ("PJM") submits this fifteenth and final informational update to the Commission. More particularly, PJM is providing the Commission with an update as to the congestion patterns on the Northern Neck Peninsula since the July 30, 2025 informational filing. In addition, this informational filing provides a final update on the upgrade to the Lanexa-Dunnsville-Northern Neck line.

A. Status of Congestion Patterns on the Northern Neck Peninsula

PJM did not observe any additional congestion on the Northern Neck Peninsula since the July 30, 2025 informational filing on congestion patterns in the Northern Neck Peninsula.³ This was partially due to the fact that the transmission work that has already been completed has significantly alleviated congestion in this area.

B. Status of Work to Upgrade the Lanexa-Dunnsville-Northern Neck line

The work to upgrade the Lanexa-Dunnsville-Northern Neck line stemming from the

baseline upgrades approved in 2020 by the PJM Board as part of PJM's regional transmission

expansion plan that was the genesis of the underlying filings in this docket has been completed.

Specifically, the rebuild of the Lanexa – Dunnsville 230 kV section of the line was completed on

July 31, 2023, while the Dunnsville – Northern Neck 230 kV section of the line was completed on

April 19, 2024.

The final component of this project to tie in the expanded bus on the Northern Neck-

Dunnsville line commenced in late March of 2025. Work on this project was paused during the

peak summer months between July and August. As construction on the project resumed earlier

this fall, the Northern Neck – Lanexa 2208 line and the expansion of the Northern Neck bus had

outages beginning in September of 2025. This final project component was completed on October

24, 2025.

Therefore, PJM's obligation to provide informational filings on congestion patterns in the

Northern Neck Peninsula "until the Lanexa-Dunnsville-Northern Neck line upgrade is complete"

has been satisfied.⁴ Accordingly, this constitutes PJM's final informational filing in this

proceeding.
