**MOTION OF PJM INTERCONNECTION, L.L.C.
FOR LEAVE TO FILE COMPLIANCE FILING
ONE DAY OUT-OF-TIME**

Pursuant to Rule 212 of the Federal Energy Regulatory Commission’s (“Commission”) Rules of Practice and Procedure, 18 C.F.R. § 385.212, PJM Interconnection, L.L.C. (“PJM”) respectfully moves for leave to submit its filing in compliance with the Order on Compliance issued by the Federal Energy Regulatory Commission (“Commission”) on July 24, 2025, and the Notice of Extension of Time issued by the Commission on Aug. 12, 2025, in the captioned proceeding one day out-of-time.¹

Pursuant to the Notice of Extension of Time, PJM’s compliance filing was due on October 22, 2025. As reflected in correspondence attached hereto as Exhibit A, PJM attempted to timely submit the compliance filing, but repeatedly encountered an eTariff error that it was unable to rectify prior to the 5:00 p.m. filing deadline.² After multiple attempts to identify the error, PJM was able to successfully submit the filing at 6:00 p.m.

PJM therefore submits this Motion for leave to file one day out-of-time to facilitate the Commission's consideration of its compliance filing.

Good cause exists to grant this Motion for leave to file one day out-of-time. As the correspondence in Exhibit A demonstrates, PJM made multiple attempts to timely submit its compliance filing, but was unsuccessful due to unforeseen technical issues with the eTariff filing system.³ Such technical issues constitute "extraordinary circumstances sufficient to justify the failure to act in a timely manner" as permitted by the Commission's regulations governing extensions of time.⁴ Moreover, the filing was successfully submitted approximately one hour after the 5:00 p.m. deadline, and all parties to this proceeding were served with the compliance filing shortly thereafter. As such, no party will be prejudiced by granting this request. PJM therefore requests that the Commission grant this motion and accept PJM's compliance filing as timely filed on October 23, 2025.
