MOTION TO DEEM INFORMATIONAL REPORT FILED FEBRUARY 2, 2026

PJM Interconnection, L.L.C. (“PJM”), pursuant to Rule 212¹ of the Federal Energy Regulatory Commission’s (“Commission”) Rules of Practice and Procedure, respectfully requests that the Commission deem today’s informational filing² to have been filed as of February 2, 2026, for the reasons set forth below.

On February 2, 2026, PJM filed, served and posted its informational filing to provide 30-days notice of the intended March 4, 2026 effective date, pursuant to the Commission’s March 31, 2025 Order. The informational filing was pending with the Commission. Subsequently, PJM submitted a ministerial clean-up filing³ to conform the previously accepted amendments to the Tariff and Operating Agreement, to be effective March 4, 2026. On February 18, 2026, PJM was notified that the February 2, 2026 informational filing should have been filed in eTariff and as such, the filing was rejected. PJM promptly resubmitted the filing in eTariff as directed.
