RE: Reactivation Notice Change Related to December 3, 2024 Reactivation Notice

Dear Mr. Schweizer:

On December 22, 2023, GenOn Energy Management, LLC ("GEM") submitted a deactivation notice for 4 industrial CT generation units at the Morgantown Generating Station located near Newburg, Maryland, a copy of which is attached hereto as Attachment A (the "Deactivation Notice"). On May 30, 2024, GenOn Energy Management, LLC ("GEM") submitted a Partial Rescission of the Deactivation Notice for the following 2 units only:

Please note that in the May 30, 2024 notice did not rescind or otherwise affect the deactivation notices submitted for CT5 and CT6 at the same site also included in the Deactivation Notice, which were originally deactivated effective June 1, 2024. On December 3, 2024, GEM provided notice to rescind the deactivation of CT 5 and CT 6 effective May 31, 2025. On June 12, 2025, GEM extended the effective date to August 31, 2025 for CT 5 and to July 31, 2025 for CT 6.


By way of this notice, GEM hereby changes the effective date to rescind the Deactivation Notice for the following unit to an effective date of **August 15, 2025** for CT 6 (note that the effective date for CT 5 remains August 31, 2025):

We also note that following a February 29, 2024 request from Morgantown Power, FERC issued an order on May 24, 2024 cancelling the rate schedule setting forth revenue requirements for Reactive Supply and Voltage Control from Generation or Other Sources Service under Schedule 2 of the PJM Interconnection, L.L.C. Open Access Transmission Tariff for Morgantown Power, LLC applicable to the units included in the Deactivation Notice.

Pursuant to Section 113.1 of the PJM Interconnection, L.L.C. ("PJM") Open Access Transmission Tariff ("Tariff"), GenOn Energy Management, LLC (GenOn) hereby submits a request for deactivation of four industrial CT generation units: CT3, CT4, CT5 and CT6 at the Morgantown Generating Station located near Newburg, Maryland (collectively, the "Units").

In accordance with the Tariff's 90-day notice requirement, GenOn requests a deactivation date of June 1, 2024.
