Generators apply for Period or Temporary Exceptions:

Period exception for 6 month periods April 1 – September 30; October 1 – March 31 Temporary Exceptions for up to 7 days Entered through eMKT and no limits

- Temporary exceptions, submitted with reason and expected term, maximum of 30 days


• Temporary exception can be extended to period or persistent exception if requirements are met
