

Markets and Reliability Committee PJM, Conference and Training Center, Audubon, PA August 23, 2018 9:00 a.m. –3:00 p.m. EPT

Administration (9:00-9:05)

Ms. Suzanne Daugherty and Ms. Christina Stotesbury welcomed stakeholders and provided the Antitrust and Code of Conduct announcement.

Ms. Daugherty noted that the contract with Monitoring Analytics (MA) had been extended to the end of 2025 subject to the filing of the extension with the Commission. She noted that it is essentially a continuation of the existing contract and business terms. PJM and MA agreed to enhanced data sharing to assist PJM in performing its functions around Avoidable Cost Rates, Fuel Cost Policies, and the similar responsibilities. PJM and MA agreed to a process assessment by a third party. In addition, although not specifically articulated in the contract extension, the parties agreed to enhance the opportunity for stakeholders to provide feedback on IMM performance to the PJM Board.

Endorsements/Approvals (9:05-11:40)

1. Draft Minutes (9:05-9:10)

Minutes of the July 26, 2018 meeting of the Markets and Reliability Committee (MRC) were **approved** by acclamation with no objections or abstentions.

2. PJM Manuals (9:10-9:20)

- A. Mr. Art Wolfe presented general changes being made to Manual 14C: Generation & Transmission Interconnection Facility Construction. Following discussion, the committee <u>endorsed</u> the proposed revisions by acclamation with no objections or abstentions.
- 3. Market Efficiency Process Enhancement Proposal (9:20-9:50)
 - A. Mr. Nicolae Dumitriu presented the Market Efficiency phase 1 proposal developed at the Market Efficiency Process Enhancement Task Force (MEPETF), and the associated Manual 14B: Regional Transmission Planning Process and Operating Agreement (OA) revisions. Following discussion, the committee <u>endorsed</u> the proposed revisions in a sector-weighted vote with 3.87 in favor.
 - B. Mr. Nicolae Dumitriu will present proposed Market Efficiency changes to Manual 14F: Competitive Planning Process. Following discussion, the committee <u>endorsed</u> the proposed revisions by acclamation with no objections and one abstention.
- 4. Order 1000 Transmission Project Cost Containment Provisions (9:50-10:20)

Ms. Sharon Segner, LS Power, moved, and Ms. Susan Bruce, McNees Wallace & Nurick LLC on behalf of the PJM Industrial Customer Coalition, seconded a motion to extend the deadlines for



development of cost containment frameworks approved at the May 2018 MRC meeting for one year. Following discussion, the committee **<u>approved</u>** the motion by acclamation with one objection and three abstentions.

5. Financial Transmission Right (FTR) Liquidation Process (10:20-11:00)

- A. Ms. Suzanne Daugherty presented a draft problem statement and issue charge related to the FTR liquidation process for which the first read was completed at the August 10, 2018 Special MRC on this topic. Following discussion, the committee <u>approved</u> the problem statement and issue charge by acclamation with five objections and one abstention.
- B. Mr. Jason Barker, Exelon, moved and Ms. Adrien Ford, Old Dominion Electric Cooperative (ODEC), seconded a motion requesting PJM to file appropriate document(s) at FERC to discontinue offering any positions in the defaulted portfolio for liquidation effective August 24, 2018 through November 30, 2018 in order for the committee to complete the work in the issue charge and submit any resulting governing document revisions to FERC for its consideration. Mr. David Pratzon proposed a friendly amendment to change the completion date to one month earlier. This was not accepted as a friendly amendment and therefore it was not incorporated into the main motion. Mr. Paul Sotkiewicz, Elwood Energy, LLC, proposed a friendly amendment to allow PJM discretion to allow month to month decisions on what to offer in monthly auctions in order to minimize losses for the period August 24, 2018 through November 30, 2018 referenced in the Exelon / ODEC motion. This was not accepted as a friendly amendment as a friendly amendment and therefore it was not incorporated into the main motion.

Mr. Greg Pakela, DTE Energy, moved motion and Mr. Bruce Bleiweis, DC Energy, seconded an alternate motion to "offer 50% of the prompt month FTR positions from the portfolio on which GreenHat defaulted for liquidation in the applicable monthly FTR auction and allow 50% of the FTR positions on which GreenHat defaulted to go to settlement as an interim step from August 24, 2018 through November 30, 2018."

Following discussion the main motion (the Exelon/ODEC motion) was **<u>approved</u>** in a sectorweighted vote with 4.04 in favor.

The endorsed main motion will be presented for approval in a single agenda item August 23, 2018 Members Committee meeting to facilitate timely filing by PJM.

6. Transmission Replacement Process (11:00-11:40)

- A. Mr. Ed Tatum, American Municipal Power (AMP), presented a proposal for addressing End of Life facilities in the PJM planning process, including revisions to Manual 14B: Regional Transmission Planning Process. Based on the changes in this proposal compared with the proposal presented at the July 26, 2018 MRC meeting, this presentation was considered the first read of AMP's current proposal.
- B. Mr. Ken Seiler discussed PJM's perspective on Manual 14B: Regional Transmission Planning Process to address End of Life facilities in the PJM planning process.



First Readings (11:40-1:55)

7. <u>Behind-the-Meter Generation (11:40-12:00)</u>

Mr. Pete Langbein provided a first read of a proposal and associated manual revisions developed by the Distributed Energy Resources Subcommittee (DERS) that would give PJM and Transmission Owners better observability of Behind the Meter Generation resources. The committee will be asked to endorse this proposal and the associated manual revisions at its next meeting.

8. Market Seller Offer Cap Balancing Ratio Proposal (12:00-12:20)

Mr. Pat Bruno presented a first read of the market seller offer cap balancing ratio proposal approved by the Market Implementation Committee. The committee will be asked to endorse this proposal at its next meeting.

9. Quadrennial Review (12:20-12:40)

Mr. Gary Helm presented a first read of the Quadrennial Review packages and the voting results from the Market Implementation Committee meeting of August 8, 2018. An update of the PJM package will be discussed. The committee will be asked to endorse a package proposal at its next meeting.

10. Opportunity Cost Calculator (12:40-1:00)

Mr. Bob O'Connell, Panda, presented a first read of proposed OA Schedule 2 revisions related to Opportunity Cost Calculators. Mr. John Rohrbach, ACES on behalf of SMECO, moved and Mr. Bob O'Connell seconded that the committee vote on the proposal at its first read. There were no objections this motion to vote at first read. Mr. O'Connell and Mr. Rohrbach accepted a friendly amendment which appends the following to the end of the proposed revision: "Any market participant using an Opportunity Cost adder must designate what Opportunity Cost Calculator it will use and may change that designation no more frequently than annually." Following discussion, the committee <u>endorsed</u> the proposed revisions to OA Schedule 2 by acclamation with no objections and 47 abstentions.

Lunch (1:00-1:30)

11. Governing Documents Enhancement & Clarification Subcommittee (GDECS) (1:30-1:40)

Mr. Rami Dirani presented proposed Tariff and OA revisions developed by the GDECS. The Committee will be asked to endorse these proposed revisions at its next meeting.

- 12. PJM Manuals (1:40-1:55)
 - A. Ms. Bilge Derin presented proposed revisions to Manual 01: Control Center and Data Exchange Requirements. The committee will be asked to endorse the manual revisions at its next meeting.
 - B. Ms. Gabrielle Genuario presented proposed revisions to Manual 15: Cost Development Guidelines as part of the Biennial Review. The committee will be asked to endorse these revisions at its next meeting.



C. Mr. Jerry Bell presented proposed revisions to Manual 21: Rules & Procedures for Determination of Generating Capability. The committee will be asked to endorse these revisions at the next meeting.

Informational Updates (1:55-3:00)

13. FERC Order 844: Uplift Cost Allocation and Transparency (1:55-2:10)

Mr. Rami Dirani provided an overview of OA revisions to comply with Order 844 to be filed on September 7.

14. Regulation Market Issues (2:10-2:25)

Mr. Adam Keech discussed recent regulation market clearing price issues including a draft problem statement and issue charge.

15. Variable Operations and Maintenance (2:25-2:45)

Ms. Melissa Pilong provided stakeholders with an update on the feedback staff has received from stakeholders since the July MRC meeting. Ms. Pilong also reviewed an updated proposal for stakeholder consideration which is documented in draft revisions to Manual 15: Cost Development Guidelines, the Operating Agreement and Tariff. Mr. Brian Wilkie, Rockland Electric, requested that these proposed revisions be brought for endorsement at the committee's next meeting.

16. Preliminary 2019 PJM Project Budget (2:45-3:00)

Mr. Jim Snow reviewed PJM's preliminary 2019 project budget.
