 - Mr. Anders noted that seven members had withdrawn since the last meeting.

Noting that there were no objections or abstentions when endorsing the proposed Tariff revisions associated with the minimum per-MWh FTR credit proposal at the July 26, 2018 Markets & Reliability Committee (MRC) meeting, Mr. Mike Borgatti proposed that item 1 be moved from the Endorsements section of this meeting agenda to the Consent Agenda; there were no objections. Similarly, Mr. Chuck Dugan, EKPC, proposed that the revisions to the Reliability Assurance Agreement (RAA) to address an issue identified with atypically low customer load during winter peak load calculation period endorsed by acclamation with no objections or abstentions at the July 26, 2018 MRC meeting be added to the Consent agenda for this meeting; there were no objections.
