Administration (9:00-9:55)

1. Ms. Sue Glatz, PJM, called the meeting to order and Ms. Anisha Fernandes, PJM, reviewed the Antitrust, Code of Conduct, media participation, and WebEx guidelines.
2. Ms. Sue Glatz informed the Committee about an amended Problem Statement and Issue Charge that was received for Item 4, which would be included as an additional presentation for Item 4 on the Agenda. After discussion about the timing of the posting and accepting this addition, it was allowed to be presented. The remainder of the Agenda was reviewed for the August 8, 2019 Planning Committee meeting. The Planning Committee approved the Agenda.
3. Ms. Anisha Fernandes reviewed the draft minutes posted for the July 11, 2019 meeting and the Planning Committee approved the minutes.

4. End of Life Problem Statement and Issue Charge

Mr. Ed Tatum, AMP, presented a Problem Statement and Issue Charge related to End of Life planning sponsored by AMP and ODEC. Mr. David Scarpignato, Calpine, requested a friendly amendment related to addressing planning horizon requirements in the issue content.

Mr. Alex Stern, PSEG, presented a proposed friendly amendment to the above Problem Statement and Issue Charge related to Asset Management and Condition planning sponsored by The Dayton Power and Light Company (DPL), Exelon Corporation, Public Service Electric & Gas Company (PSE&G), PPL Electric Utilities Corporation (PPL). Extensive stakeholder discussions ensued around term definitions and past TRPSTF work related to the problem statement and issue charge and the proposed amendments.

In order to allow the sponsors and stakeholders more time to discuss and review the Problem Statements and Issue Charges, the vote to endorse after the First Read was deferred to the next Planning Committee meeting.

5. Manual 14F Revisions

Mr. Mark Sims, PJM, presented revisions to PJM Manual 14F Competitive Planning Process related to the cost containment process. A workshop is scheduled for August 29th to review manual language and next steps. The Committee will be requested to endorse these revisions at the next meeting.

Load Forecast Update

PJM is proposing some changes to the load forecast model that were discussed at the LAS meeting of Aug. 6. For more information, please refer to the material that was posted for the Aug. 6 LAS meeting. PJM will review the proposed changes with the PC in September and then draft Manual language changes that will be reviewed through the stakeholder process up to the MRC. Any model changes would become effective with the 2020 Load Forecast Report to be issued in late Dec/early Jan 2020.

Special Session of the Planning Committee on Merchant Transmission and Offshore Wind

At the most recent meeting on June 15, PJM presented additional details on, along with examples, for the previously proposed PJM solution options. Following the meeting PJM released a poll to determine stakeholder preferences regarding: the temporary "XCIR" concept; possible changes to the generation
