1. April 23, 2021

A lot of education and fact finding was performed at the Interconnection Process Workshops during the latter half of 2020. Due to this, a short review of the education relating to the interconnection process was provided at the April 23 meeting. The group began work on the CBIR matrix. A large number of interests were gathered and noted in the matrix.

2. June 1, 2021

During the second meeting, the group reviewed the interests gathered during the April 23 meeting and any additional interests gathered between meetings. The group utilized the majority of the meeting's time to the gather design components. The meeting was very fruitful, as over 80 design components were identified.

The next meeting is scheduled for June 29, 2021. The group has been tasked with using the gathered design components to begin crafting their desired solution options. The participants were also asked to work with others that may share the same interests to help consolidate the proposals.
